REGULAR TOWNSHIP COUNCIL MEETING

June 10, 2013

The Regular Meeting of the Township Council of the Township of Vernon was convened at 7:30pm on June 10, 2013, in the Vernon Township Municipal Building, 21 Church Street, Vernon, New Jersey, with Council President Patrick Rizzuto presiding.

STATEMENT OF COMPLIANCE

Adequate notice of this meeting had been provided to the public and the press on January 11, 2013, and was posted on the bulletin board in the Municipal Building in accordance with the Open Public Meetings Act, N.J.S.A. 10:4-6.

ROLL CALL OF MEMBERS

Present were Council Members Eddie Dunn, Daniel Kadish, Brian Lynch, Dick Wetzel, and Council President Patrick Rizzuto. Also present were Mayor Vic Marotta, Business Administrator Jerry Giaimis, and Township Attorney Kevin Kelly.

SALUTE TO THE FLAG

The Council President led the salute to the flag.

PRESENTATION - FATHER BOLAND

The Council President spoke about Father Boland:

"Every once in a while a person comes along whose presence touches so many lives, and it's indeed a privilege to know that person. And it's indeed an even greater privilege to call that person a friend. Such a person, such a man, lives in Vernon, and he is here with us this evening. I am proud to call him my pastor of our church, proud to call him my friend, and I think the people of Vernon also can be proud to call him their friend. I've know Father Boland for over 35 years. During that time, his life and his hand has touched many people. It goes beyond the confines of our parish, and the members of our parish. It goes to the members of our community. I know many people who have been helped and aided by this man, and they consider him a very close friend. Because of that, I'd like to read this proclamation."

Council President Rizzuto read the following proclamation:





Whereas, Father John V. Boland, son of John and Nora Boland was born in Eyrecourt County Galway, Ireland and following his education was ordained at St. Patrick's College in Carlow Ireland in 1965; and

Whereas, Father Boland arrived in the United States in 1965 to serve in the Diocese of Paterson, his first assignment being at the Church of Our Lady of the Magnificat, Kinnelon from 1965-1969 and then was assigned to Pope John High School as its principal and as Vicar of Sussex County;

Whereas, in June of 1979, the Most Reverend Frank J. Rodimer, Bishop of Paterson, appointed Father Boland pastor of the new parish of St. Francis de Sales with its Church located on Rt. 94 and Rudetown Rd. during which time the parish flourished under his spiritual guidance and inspirational leadership requiring construction of a new and larger church on Rt. 517 which was dedicated August 24, 1986;

Page 1 of 13 June 10, 2013 **Whereas**, Father Boland continues to exemplify the teachings of the Church, preaching the gospel, providing help to the less fortunate with the establishment of food pantries, counseling those in need, offering help and guidance to our veterans and has spent over 34 years as a friend to Vernon and its people;

Whereas, on July 1, 2013 Father Boland will be retiring from the active priesthood and will be missed by all in our community.

Now therefore be it Proclaimed that the Council of the Township of Vernon in the County of Sussex in the State of New Jersey hereby declares,

June of 2013 to be "FATHER BOLAND MONTH"

in Vernon Township in recognition of his service and devotion to the people of Vernon.

Presented this 10th day of June, 2013 Victor J. Marotta, Mayor Township of Vernon

Mayor Marotta presented Father Boland with the framed Proclamation, noting that Mr. Rizzuto had "said it all," and that he hoped it would be held in a place so dear to his heart as he is to ours.

Father Boland had the following to say:

"Over the past 34 years, I can very easily say that Vernon has become a home. In listening to the Council President reading off this proclamation, I was looking around the room to see who was this all about. I suppose when you look back over 34 years it is very difficult to really realize that so much has been accomplished. But, as I think, and as the Council President knows, I am a firm believer in the collaborative ministry; and even though I was present as Pastor, nevertheless, I can honestly say that none of this would have happened without the people of this unbelievable Township. And I want to express particular thanks to the Councils in the past, and the representatives of our community, 'cause I sat here time and time again for different meetings, and I have seen Vernon progress, really, from when I came here 30 and 40 years ago. I can very easily say that there were more sheep and cattle in Vernon that there were people. I have seen this place grow. I think we can all recall times in our lives when we figure, we can do a better job than the people already in positions up here." He referred to a Dr. Schweitzer statement that stuck with him over the years, "No one of us knows more than all of us." He continued, "it changed me to realize that there is incredible talent in the minds and hearts of people like yourselves, and the people of Vernon in general. It is in the back of his mind to appreciate this incredible place we call Vernon, as it is a very, very special place." He recalled a few anecdotes over the years. He thanked everyone for the memories, and noted that the people of Vernon have really become his family.

PUBLIC COMMENTS

Council President Rizzuto asked for a motion to open the meeting to public comments at this time.

MOVED: Brian Lynch SECOND: Dick Wetzel

All were in favor.

Mary Bradley – thanked everyone for coming out for Vernon Day, noting that it was a great success. She had special thanks for Missi Wiedbrauk (Recreation Director), and

"Digger" (Craig Leidig) and his DPW team for all their hard work. She also thanked the members of the Board of Recreation.

Council President Rizzuto agreed that it was a great time, and the employees who worked to get everything ready were very dedicated.

Mary Chambers of Pleasant Valley Lake – thanked the Council and the Road Dept. for correcting the problem on Evergreen. She noted that after all the rain that day, there were no water problems.

Doreen Edwards – noted that Breakneck Road needed repairs. She reported that the directional arrows at the light by the Rite Aid are hard to see.

The Council President advised that the condition of Breakneck is well known to the Council. The Mayor noted that the 2013 budget included \$200,000 as part of a Dept. of Transportation grant application (a total of @\$700,000), but we were not successful in obtaining that grant. He added that the road is a number one priority concern for repairs.

Bill Perrecka of Laurel Lake – thanked the Council for paving Canistear. He reminded the Council that there is still a speed problem through that section of the roadway. He felt it was a dangerous condition for anyone turning off of Canistear or onto Canistear. Mr. Rizzuto noted he would ask the Mayor to speak to the Police Department.

Len Coloccia - spoke about the proposed helicopter rides over Great Gorge Village, noting that the emergency helicopter is very loud when it goes by. He re-stated his desire to have a member of Great Gorge Village on the MUA. The Council President suggested he speak to the Mayor during office hours.

Howard Greenblatt – wondered about the condo owners being mistreated relative to the MUA.

Mary Ellen Vichiconti – advised how the appointments to the various Boards are made.

Noreen Moran – spoke about Resolution #13-121 for the helicopter issue, stating that it was an intrusion on their privacy and peace.

Susan Elfein – noted that people who work night shifts would be trying to sleep during the day with the extra noise.

Sandra Ooms – commented on the OPRA lawsuit, feeling that it all could have been easily avoided through direct contact.

Krista Gherry – was glad for Father Boland, and was glad that the Council helped Jamie Rickey. She then had comments on the OPRA lawsuit issue.

Jessi Paladini – noted that she had come to celebrate Father Boland. She commented on the OPRA lawsuit issue in defense of the Council's decision to pursue a lawsuit.

Jean Murphy – read a prepared statement on the OPRA lawsuit issue as well. When her five minutes had expired she was asked to sit down by the Council President.

Sally Rinker – began to continue Ms. Murphy's statement. As she was informed that Ms. Murphy's time had expired, Ms. Rinker's words became heated. The Council President asked her to sit down as she was out of order and was making libelous statements. Ms. Rinker would not cooperate with the Council President.

Gary Martinsen – felt that Vernon Day went very well, and felt that there were a number of children who helped out. On Resolution #13-121 he was concerned with the issue not being presented to the public prior to discussion of the matter at tonight's meeting. He felt the issue needed an impact study and possibly an environmental study.

CLOSED TO PUBLIC COMMENTS

No one else wished to speak at this time, and Council President Rizzuto asked for a motion to close the public portion of the meeting.

All were in favor.

MAYOR'S REPORT

Mayor Marotta reported on the following items:

- ➤ He noted that the Council members had all received a budget report through May 31.
- Advised that the Township applied to the Environmental Protection Agency for a grant to replace trees by the pipeline we were awarded \$30,642.00, with no municipal match required. He advised that the grant application was put together by the Environmental Commission, led by Bev Budz. He noted that we were awarded the grant in record time of two weeks!
- Advised about the Clean Communities Grant to keep streets, waterways, and byways clean. We were awarded \$49,274.00, which is based on taxes collected by waste-producing companies in Vernon. It is the highest amount we have received.
- ➤ He received notification early on June 7 that Dave Tynan had applied to FEMA for an Assistance to Firefighter Grant in the amount of \$342,562.00. The Township is responsible for close to 10% or \$38,063.00. This is to complete the radio frequency upgrade. He thanked FEMA and Homeland Security.
- ➤ He advised that repairs to the Lake Conway communications system would be close to \$500,000.00 total.

Council President Rizzuto thanked Mr. Tynan for submitting the Assistance to Fire Fighters Grant application.

PUBLIC AUCTION

Mr. Kelly explained the auction process, noting that there were 2 parcels for auction:

- a) 10 Barberry Street, Block 90.05 Lot 5, as per Ordinance #13-07; and
- b) 8 Clover Lane/2 Gilbert Drive, Block 83.08 Lot 2, as per Ordinance #13-08.
- a) Thomas Nye was the only eligible property owner in attendance. He offered a bid of \$500.00, and presented the Clerk with a check in that amount. He was advised that there were additional fees as stipulated in the ordinance that would be owed at a later date.
- b) Mark Zaremba was the only eligible property owner in attendance. He offered a bid of \$100.00, and presented the Clerk with a check in that amount. He was advised that there were additional fees as stipulated in the ordinance that would be owed at a later date.

RESOLUTION FOR DISCUSSION

Resolution #13-121: Municipal Consent for Eagles Arie LLC

The Council President asked for a motion to adopt Resolution #13-121.

MOTION: Dick Wetzel SECOND: Eddie Dunn

Mayor Marotta explained that Mr. Fussman was in attendance to answer any questions that Council had. Mr. Kelly noted that this use is governed entirely by the Department of Transportation, and that a 1983 Supreme Court decision noted that the DOT must take into account comments by the town, but that no approval is required.

Mr. Fussman addressed the concerns raised earlier by the residents. He advised that he is a resident of Vernon, and that he owns a flight school in the area and has had no complaints. He further advised that he had no intentions of creating a nuisance, that the flights would only be over the ski area, and that any flights over the Walkill River and Delaware River are at high altitude.

Council Member Dunn asked about the flight paths, which Mr. Fussman promised to provide. Mr. Dunn asked how high he would need to go to make less noise. Mr. Fussman advised that it would be about 900 feet. Mr. Fussman added that there was no set altitude in mind, but that he would use direct routes without damage to any areas.

Council President Rizzuto asked how many flights he was planning on and Mr. Fussman replied that he hoped for a lot.

Mr. Fussman explained that the flights would be very short, comparing them to the flights to the Walkill River (30 minutes) and the Delaware River (40 minutes). Mr. Fussman also responded to an earlier complaint about the noise of the medivac helicopter, noting that it has a jet engine while he flies a single engine piston which is about ½ as loud. He noted that if the trip over the hotel becomes a problem, he would be willing to cancel that flight path. He advised that he would not be using the medivac helipad.

The Council President asked if he would consider changes to the flight paths if complaints came in. Mr. Fussman said that would certainly be considered.

Council Member Lynch noted his negative experiences with landing zones as a firefighter, advising that he had no problem with necessities such as medivacs, but wasn't sure that this type of recreational usage was needed, as he felt it was a safety issue.

Council Member Dunn noted his positive experience as a military man, but was also concerned with the need.

A motion was made to table Resolution #13-121:

ORDINANCE # 13-13

AN ORDINANCE OF THE TOWNSHIP OF VERNON, COUNTY OF SUSSEX, STATE OF NEW JERSEY, AUTHORIZING THE SALE OF CERTAIN PROPERTY OWNED BY THE TOWNSHIP AND NOT REQUIRED FOR PUBLIC PURPOSES AND MORE COMMONLY KNOWN AS 44 CURVING HILL DRIVE, BLOCK 103.23, LOT 6

WHEREAS, the Local Lands and Buildings Law, <u>N.J.S.A.</u> 40A:12-13 authorizes the sale by municipalities of any real property, capital improvements or personal property, or interest therein, not needed for public use by open public sale at auction to the highest bidder after the required newspaper advertisements; and

WHEREAS, the Township of Vernon is the owner of certain real property known as 44 Curving Hill Drive, Block 103.23, Lot 6; and

WHEREAS, said property is not needed for public use, and the Township Council has determined that it is in the best interest of the Township to sell the property; and

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Vernon, County of Sussex, State of New Jersey, that:

- 1. The property known as 44 Curving Hill Drive, Block 103.23, Lot 6 shall be offered for sale by open public sale at auction to the highest bidder, pursuant to N.J.S.A. 40A:12-13. Said auction shall be conducted on July 8, 2013 at 7:30 p.m. at the Municipal Building, 21 Church Street, Vernon, New Jersey.
 - 2. This property shall be sold subject to the following terms and conditions:
 - (a) There is no minimum bid price.
- (b) After legal advertisement of this Ordinance the sale shall be made to the highest bidder at public auction.
- (c) The Township does not warrant or certify title to the property and in no event shall the Township of Vernon be liable for any damages to the purchaser-successful bidder if title is found unmarketable for any reason. The purchaser-successful bidder waives any and all right in damages or by way of damages.
- (d) Acceptance of the highest bid shall constitute a binding agreement of sale and the purchaser shall be deemed to agree to comply with the terms and conditions of the sale herein contained.

- (e) Upon acceptance of the bid, the purchaser shall be required to pay ten percent (10%) of the bid plus \$450.00 to cover the Township's transaction costs, in cash or by check.
- (f) A Quit Claim Deed without covenants will be delivered at the office of the Township Clerk within thirty (30) days, at which time and place the balance of the purchase price shall be required to be paid in cash or by bank check. The Mayor and Clerk are hereby authorized to execute said Deed.
- (g) The Deed of Conveyance will be subject to all matters of record, which may affect title herein, what an accurate survey may reveal, the Ordinances of the Township of Vernon and reserving an easement for all natural or constructed drainage systems, waterways and water easements on the premises, if any, and the continued right of maintenance and flow.
- (h) The property will be sold subject to 2012 taxes, pro-rated from the date of delivery of the Deed under subsection 2(g).
- 3. Where all bids have been rejected a private sale is hereby authorized pursuant to N.J.S.A. 40A:12-13(b).

Effective Date.

This Ordinance shall take effect upon final passage and publication as provided by law.

Council President Rizzuto advised that the Council must always consider the possible outcomes of decisions that might lead to litigation, but noting that the outcome of what is now being seen justifies the decision taken, as well as the judge's decision. He further advised that the Township Attorney would be present at a future court date to ensure that the judge's decision is honored in the best interests of the Township and our employees.

Mr. Rizzuto noted that Vernon Day was a wonderful event. He congratulated the Recreation Department, the Department of Community Affairs, and the Recreation Board. He complained, however, that there were no zeppoles!
