RESOLUTION #14-124

SUPPORTING AN INITIATIVE TO ALLOW POLICE OFFICERS AND EMTs TO CARRY AND ADMINISTER THE LIFE SAVING HEROIN ANTIDOTE NARCAN (NALOXALONE HYDROCHLORIDE)

WHEREAS, the Vernon Township Police Department has seen an increase in calls due to the rise of the use of heroin; and

WHEREAS, in April 2014, Governor Chris Christie announced the formation of a pilot program in Ocean and Monmouth Counties that will train and equip police officers to administer the antidote Narcan to persons suffering from an overdose of heroin or prescription narcotics; and

WHEREAS, Governor Christie describes the Narcan program as a vital, life-saving element of the State's approach to our drug problem, which also includes vigorous awareness, enforcement and anti-addiction efforts; and

WHEREAS, the Attorney General's Office and the Department of Heath and the Department of Human Services have conducted reviews and made revisions to the model pilot program; and

WHEREAS, the Narcan pilot program includes the following elements:

- a. Each local law enforcement agency must utilize a Standard Operating Procedure for the use of Narcan;
- b. Each agency must designate a Narcan Program Coordinator who will be responsible for training all police personnel at their agency and ensuring Narcan kits are properly deployed;
- c. A County Coordinator is designated in each participating county to oversee the training and distribution of Narcan kits to the municipal Program Coordinators after all personnel are trained;
- d. Training is accomplished through a "Train the Trainers" model whereby a designated officer participates in training sessions, then takes that training back to his or her home policing agency and trains follow officers; and
- e. Each municipal officer's name and training certification is supplied to the County Coordinator prior to issuance of the Narcan kits. Narcan kits are prescribed for each officer, once that officer has been certified after training.

WHEREAS, the Township of Vernon fully supports the initiatives and goals of this pilot program;

NOW, THEREFORE, BE IT RESOLVED by the Council of the Township of Vernon that the Council supports the implementation of a pilot program similar to that in Ocean and Monmouth County which has already begun to be implemented in Sussex County.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Council of the Township of Vernon support the action taken by the Sussex County Prosecutor Francis A. Koch and his office as well as the Vernon Township Police Department in extending this pilot program to Sussex County and Vernon Township.

OPPOSING EXPANSION OF FEDERAL CONTROL UNDER CLEAN WATER ACT

WHEREAS, the U.S. Environmental Protection Agency (EPA) and the Army Corps of Engineers (Corps.) have released a 371 page draft regulation for Definition of Waters of the U.S. under the Clean Water Act; and

WHEREAS, both agencies are seeking a rule change to give the federal government more authority by expanding the definition of "navigable waters" in the Clean Water Act; and

WHEREAS, the rule change proposed by the EPA and the Corps would subject almost all physical areas with a connection to downstream navigable waters, including features such as ditches, natural or man-made ponds, and flood plains, to the jurisdiction of the Clean Water Act; and

WHEREAS, the proposed rule change, if adopted, will cause significant harm to local farmers, stall the development of businesses, take control of land use for sustainable food production out of our local providers' hands, and negatively impact County-owned and maintained infrastructure such as roadside ditches and flood control channels; and

WHEREAS, the cost to our farms, municipalities and taxpayers will pose yet another undue economic burden; and

WHEREAS, it is impractical for the federal government to regulate every ditch, pond and rain puddle that may have some tenuous connection, miles away, to a body of water currently defined as "navigable",

NOW, THEREFORE, BE IT RESOLVED that the Council of the Township of Vernon hereby strongly opposes the EPA and Corps expansion of the Clean Water Act, as proposed; and

BE IT FURTHER RESOLVED that three (3) copies of this Resolution be forwarded to "Water Docket, Environmental Protection Agency, Mail Code 2822T, 1200 Pennsylvania Avenue NW, Washington, D.C. 20460, Attention: Docket ID NO EPA-HQ-OW-2011-0880; and
