WHEREAS, in 2011 the State of New Jersey instituted a best practices checklist in an effort to "make government operate more efficiently, strengthen its accountability, and better manage scarce taxpayers' resources", and;

WHEREAS, since the inception of the best practices checklist, the Township of Vernon has made every effort to comply with the standards established by the State; and

WHEREAS, the best practices checklist recommends the adoption of a fund balance policy to serve as a basis for decisions regarding future solvency; and

WHEREAS, Fund Balance is created by realizing more revenue than budgeted and by spending less than budgeted. It is also created by miscellaneous revenue not anticipated, return of interfunds and establishment of reserves such as reserve for uncollected taxes, snow removal and property tax appeals; and

WHEREAS, the Township Auditor and Chief Financial Officer have considered the factors affecting fund balance and evaluated the historic budget and financial records and recommended to the Governing Body a goal of maintaining sufficient fund balance; and

WHEREAS, the Township Chief Financial Officer has analyzed the Township's fund balance trends over the last 5 years and explained the importance of maintaining a reasonable fund balance to promote better budgeting practice, foster reasonable tax rate management and ensure a strong credit rating; and

NOW, THEREFORE, BE IT RESOLVED that the Governing Body does hereby concur with the goal of consistently maintaining sufficient fund balance in the annual budgeting process as recommended by the Township Auditor and Chief Financial Officer,

BE IT FURTHER RESOLVED, the fund balance policy goal shall be as described in the attached Appendix,

BE IT FURTHER RESOLVED that the Governing Body shall strive to achieve this fund balance policy goal annually during the budget process.

RESOLUTION AUTHORIZING THE ISSUANCE OF NOT EXCEEDING \$1,300,000 BOND ANTICIPATION NOTES OF THE TOWNSHIP OF VERNON, IN THE COUNTY OF SUSSEX, NEW JERSEY.

BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF VERNON, IN THE COUNTY OF SUSSEX, NEW JERSEY, AS FOLLOWS:

Section 1. Pursuant to a bond ordinance of the Township of Vernon, in the County of Sussex (herein called "local unit") entitled: "Bond ordinance providing for the restructuring of a portion of the cost of acquisition of capacity at the sanitary sewage treatment plant of the Sussex County Municipal Utilities Authority by the Township of Vernon, in the County of Sussex, New Jersey, appropriating \$2,800,000 therefor and authorizing the issuance of \$2,666,000 bonds or

notes of the Township for financing such appropriation", finally adopted on November 14, 2011 (#11-23), Bond Anticipation Notes of the local unit in a principal amount not exceeding \$1,300,000 shall be issued for the purpose of temporarily financing the improvement or purpose described in Section 3 of said bond ordinance, including (to any extent necessary) the renewal of any Bond Anticipation Notes heretofore issued therefor.

- Section 2. The following matters in connection with said Bond Anticipation Notes are hereby determined:
- (a) All notes issued hereunder shall mature at such times as may be determined by the chief financial officer or the interim chief financial officer (the "chief financial officer") of the local unit, <u>provided that</u> no note issued pursuant to Section 1 shall mature later than (i) one year from the date of the first such note issued pursuant to the respective ordinances referred to in said Sections, and (ii) three years from the date of the first note issued pursuant to each such respective ordinance unless the local unit shall have paid and retired amounts of such notes sufficient to allow it, in accordance with provisions of Section 40A:2-8 of the Local Bond Law, to renew a portion thereof beyond the third anniversary date of the first of such notes;
- (b) All notes issued hereunder shall bear interest at such rate or rates as may be determined by the chief financial officer of the local unit; and
- (c) The notes shall be in the form prescribed by resolution heretofore adopted by the governing body of this local unit determining the form of Bond Anticipation Notes issued pursuant to the Local Bond Law, and any such notes may be signed or sealed by officers of the local unit in any manner permitted by Section 40A:2-25 of said Local Bond Law notwithstanding that said form or resolution may otherwise provide.
- Section 3. The chief financial officer of the local unit is hereby authorized and directed to determine all matters in connection with said notes not determined by this or a subsequent resolution, and the chief financial officer's signature upon said notes shall be conclusive as to such determinations.
- Section 4. The chief financial officer of the local unit is hereby authorized to sell said Bond Anticipation Notes from time to time at public or private sale in such amounts as the chief financial officer may determine at not less than par and to deliver the same from time to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof and payment therefor.
- Section 5. Any instrument issued pursuant to this resolution shall be a general obligation of the local unit, and the local unit's faith and credit are hereby pledged to the punctual payment of the principal of and interest on said obligations and, unless otherwise paid or payment provided for, an amount sufficient for such payment shall be inserted in the budget and a tax sufficient to provide for the payment thereof shall be levied and collected.
- Section 6. The chief financial officer of the local unit is authorized and directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of notes pursuant to this resolution is made, such report to include the amount, description, interest rate and maturity of the notes sold, the price obtained and the name of the purchaser.
- Section 7. The chief financial officer of the local unit is hereby authorized and directed to do all other matters necessary, useful, convenient or desirable to accomplish the delivery of said notes to the purchasers thereof as promptly as possible, including (i) the preparation, execution and dissemination of a Preliminary Official Statement and Final Official Statement with respect to said notes, (ii) preparation, distribution and publication, if necessary, of a Notice of Sale with respect to said notes, (iii) execution of a Continuing Disclosure Undertaking, with respect to said notes in accordance with Rule 15c2-12 promulgated by the Securities and Exchange Commission and (iv) execution of an arbitrage and use of proceeds certificate certifying that, among other things, the local unit, to the extent it is empowered and allowed under applicable law, will do and perform all acts and things necessary or desirable to assure that interest paid on said notes is not included in gross income under Section 103 of the Internal Revenue Code of 1986, as amended.
 - Section 8. This resolution shall take effect immediately.

Council Member Murphy stated she would like a disclaimer on the show Vernon Vibes that this is the Mayor's opinion of the council's meetings. Council Member Murphy asked the Township Attorney to provide information about work sessions. Township Attorney Kelly pointed Council Member Murphy to NJSA 10:4-12 but further indicated he would provide a memo on this information if the Council would like.

Council Member Rizzuto had no comments.

Council President Lynch was not present.
