#### VERNON TOWNSHIP COUNCIL REGULAR MEETING MINUTES OCTOBER 24, 2022 7:00 PM

This Meeting of the Township Council of the Township of Vernon was convened at 7:00 p.m. on October 24, 2022 via Zoom Webinar and in the Vernon Municipal Center, 21 Church Street, Vernon, New Jersey with Council President Patrick Rizzuto presiding.

# **REVIEW OF BILLS LIST**

The Council Reviewed the Bills List

### MAYOR COMMENTS

Mayor Burrell commented that eleven days ago, at our last Council meeting, Mr. Harry Shortway announced his resignation from our Municipal Council, and from elective civic service, after serving the people of Vernon in elected positions for almost eight and a half years. During this almost eight and a half years period, Mr. Shortway served the people of Vernon not only as a member of their Municipal Council, but also as their Council President and their Mayor. Mr. Shortway now moves on to fight another, more serious battle, one related to his health. As he begins his intense focus on this battle, I have told him in private, and I do so here again in public, that he enters this battle with my respect, with my friendship, and with my prayers.

Mayor Burrell commented saying Council President Rizzuto, this response relates to Resolution # 22-253 on tonight's agenda. In an August 1, 2022 attorney-client privileged matter I related communications to the Council and our municipal attorney, I offered a compromise proposal to the Council. This compromise was an attempt to work with the Council by offering them some results which they could use as partial justification to the public for authorizing up to \$10,000 of local taxpayer's money to pay for a second investigation that was not at all needed. However, not only did this Council not accept my compromise offer, the leader of this Council never even gave me the respect of even responding to me about my compromise offer. So how in the world could I have ever agreed with this Council on something that we never even talked about? At their September 12 meeting, the Council stated that the resolution they passed on this matter was their final word on this this matter. However, it seems that for some reason, three of the Council members have changed their minds. Now that all of the municipal employees who were interviewed for this report have recently had an opportunity to read a redacted copy of this \$10,000 report, several seriously questioned the accuracy of what this report stated that they said during these interviews. It's important for the public to know that these interviews were not recorded, and are therefore, simply the interviewers' interpretations of what each individual said. I end by asking just two Council members to give more thought to this matter; to question what they have been told or not told. To demonstrate to the residents of Vernon, their reasonableness and their independence from this current Council leadership by abstaining to vote for this resolution that does nothing but continue this unnecessary chaos.

The Council discussed some of the concerns they had about the Mayor's comments regarding resolution #22-253.

## **RESOLUTION #22-253**

#### RESOLUTION OF THE COUNCIL OF THE TOWNSHIP OF VERNON PROVIDING WRITTEN NOTICE TO THE BUSINESS ADMINISTRATOR OF, AND AN OPPORTUNITY TO RESPOND TO, CHARGES SEEKING HIS REMOVAL FOR CAUSE PURSUANT TO N.J.S.A. 40:69A-36(e) AND N.J.S.A. 40:69A-37(b)

WHEREAS, on September 12, 2022, the Township Council ("Council") unanimously passed Resolution #22-220, which, in part, adopted the independent Investigation Report authored by Lavery, Selvaggi, Abromitis & Cohen, P.C. ("Investigation Report") finding multiple systemic deficiencies and individual errors in connection with the November 2021 auction of Township owned property ("Municipal Land Sale") resulting in the sale of property located at 6 Mondamin Road ("Mondamin Tower") that included a Township owned radio tower and equipment; and

**WHEREAS**, the Investigation Report determined that the systemic deficiencies that lead to the sale of the Mondamin Tower were attributable to the Business Administrator and that the Business Administrator had also committed a series of individual errors in connection with the Municipal Land Sale; and

WHEREAS, the Council in Resolution #22-220 expressed the following:

- that the Business Administrator failed to adequately supervise, manage and conduct the Municipal Land Sale;
- that the Business Administrator had multiple opportunities to prevent the sale of the Mondamin Tower, but chose not to act on those opportunities, whether by acts of commission or omission;
- that the Business Administrator's conduct and his failure to adequately supervise, manage and conduct the Municipal Land Sale, as detailed in the Investigate Report, was the primary causal factor in the Mondamin Tower being sold erroneously;
- that it had no confidence in the Business Administrator to perform the tasks required of the Township business administrator;

- that cause exists to justify its removal of the Business Administrator for the reasons set forth in Resolution #22-220 and as contained in the Investigative Report;
- the potential for the disruption to the Township which could ensue if the Council were to effectuate the removal of the Business Administrator and that the Mayor is the person to whom should fall the responsibility of remedying this error;
- that the Township Council provided the Mayor with a copy of the Investigative Report and informed the Mayor of its opinion regarding the Business Administrator, the Business Administrator's conduct that resulted in the sale of the Mondamin Tower and its lack of confidence in the Business Administrator;
- that while the Business Administrator serves at the Mayor's discretion, the Mayor had informed the Township Council that he will not terminate the Business Administrator's employment, but instead offered to discipline the Business Administrator by suspending his pay for thirty-two (32) days;
- that while the Township Council believed that the Mayor's proposed response was inadequate, it would not seek to remove the Business Administrator at that time, fully and completely placing the responsibility and ownership of the matter on the Mayor;

**WHEREAS**, despite the assurances to the Council by the Mayor that he would impose a thirty-two (32) day suspension on the Business Administrator, the Mayor has since refused to take any action against the Business Administrator in connection with the findings of the Investigative Report, the Municipal Land Sale or the sale of the Mondamin Tower; and

**WHEREAS**, the Council remains of the opinion that it has no confidence in the Business Administrator to perform the tasks required of him;

**WHEREAS**, N.J.S.A. 40:69A-36(e) and N.J.S.A. 40:69A-37(b) allow the Township Council to remove any municipal officer for cause;

**WHEREAS**, The Township Council, based on the findings of the Investigative Report, believes that the Business Administrator has engaged in the following infractions that would constitute cause for his removal pursuant to N.J.S.A. 40:69A-36(e) and N.J.S.A. 40:69A-37(b):

- Failure to perform duties, inefficiency or substandard performance;
- Conduct unbecoming a public employee; and
- Other sufficient cause

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Vernon, County of Sussex and State of New Jersey, as follows:

1. The Township Council President or Vice President shall provide the Business Administrator notice in writing of the following charges no later than November 15, 2022 ("Notice"):

- Failure to perform duties, inefficiency or substandard performance;
- Conduct unbecoming a public employee; and
- Other sufficient cause

2. The Notice shall advise the Business Administrator that he shall have the opportunity in Executive Session at the November 21, 2022 Special Township Council meeting to respond to the foregoing charges; and

3. That immediately following the Executive Session, regardless of whether the Business Administrator chooses to respond to the charges, the Township Council shall vote on whether to remove the Business Administrator from his position for cause pursuant to N.J.S.A. 40:69A-36(e), N.J.S.A. 40:69A-37(b) and N.J.S.A. 40A:9-138.

# COUNCIL PRESIDENT COMMENTS

Council President Rizzuto explained that on any number occasions he spoke to the Mayor about this issue, but he stopped because it became a personal situation. He specifically asked members of the Council and the Attorney to approach him and point out that he alone has the ability to stop this expenditure of funds. The Mayor points to the Council and says that we are wasting money and yet he alone has the ability to call the situation to an end by terminating the employee as the employee serves at the Mayor's pleasure. The mayor mentions protecting his employees, the Council's position is to protect the resident of this township. The people who work in this building work to serve the residents of the township. Council President Rizzuto feels that the investigation clearly shows that there were times where the situation could have been rectified, corrected and stopped but if wasn't. Statements were made in effect that it was not necessary to inspect the individual sites. Council President Rizzuto asked members of the Council if they wanted to proceed and every one of them agreed that they wanted the termination to take place. In order to effectuate this removal, we will need four votes and the Mayor has convinced one member of the Council to abstain or vote no. Council President Rizzuto said if the Council cannot bring forward four positive votes on November 10<sup>th</sup>, the resolution will die.

# ADJOURNMENT

At 8:25pm Council Member Lynch made a motion to adjourn the meeting. Seconded by Council Member Furrey.
