Mayor Shortway explained transfers were needed for road improvements on Higgins & Walsh roads, to cover DPW retroactive contractual increases and uniform allowance for Glenwood Pochuck Ambulance Squad and according to the CFO and Business Administrator funds were able to be transferred. Attorney Townes added that surplus near end of year is typically transferred based on needs of Township. Council President Murphy also noted that the Resolution does transfer \$67,000 from legal line item not needed and moves \$60,000 into the Road Repairs line item.

**Resolution #19-222:** A Resolution Authorizing The Execution Of An Agreement Between The Township Of Vernon And Highland Lakes Country Club And Community Association Regarding Sidewalks Along Breakneck Road

**WHEREAS,** Highland Lakes Country Club and Community Association ("the Club") is a private, single-family, residential lake community located in Vernon Township, Sussex County, New Jersey; and

**WHEREAS**, Vernon Township is a Municipal Corporation of the State of New Jersey, located in Sussex County, New Jersey; and

**WHEREAS**, Breakneck Road is a public roadway located in Vernon Township, along which are located properties belonging to the Club and to individual members of the Club; and

**WHEREAS,** in 1985, Vernon Township determined that improvements were needed to make Breakneck Road safer to travel, for both motorists and pedestrians; and

**WHEREAS**, to enable these improvements to be made, the Club and some of its individual members conveyed certain portions of various properties located along Breakneck Road to Vernon Township in 1985 and 1986; and

**WHEREAS**, as additional consideration for these transfers, Vernon Township agreed to waive and forego enforcement, against the Club and its current and future individual members, of certain snow and ice removal, maintenance, replacement, improvement and repair obligations for the soon to be constructed municipal sidewalks abutting these properties ("Sidewalk Agreement'). However, the Sidewalk Agreement was not reduced to writing at that time; and

**WHEREAS**, the Club and Vernon Township now wish to confirm and memorialize the Sidewalk Agreement, for the benefit of the Club and its current and future individual members, who are third party beneficiaries to this Agreement.

**NOW, THEREFORE,** it is hereby resolved that the Mayor of the Township of Vernon shall be and is hereby authorized to execute the agreement attached hereto as Exhibit A memorializing the terms and conditions of the Sidewalk Agreement.

Council President Murphy questioned if the Council needs to vote on approving the DPW Agreement in order to allow retroactive increases. Mayor Shortway stated the Council did approve a Memorandum of Agreement previously but Attorney Townes added he will review Agreement to see if further action is needed by the Council.

#### AGREEMENT

WHEREAS, Highland Lakes Country Club and Community Association ("the Club") is a private, single-family, residential lake community located in Vernon Township, Sussex County, New Jersey; and

**WHEREAS**, Vernon Township is a Municipal Corporation of the State of New Jersey, located in Sussex County, New Jersey; and

**WHEREAS,** Breakneck Road is a public roadway located in Vernon Township, along which are located properties belonging to the Club and to individual members of the Club; and

**WHEREAS,** in 1985, Vernon Township determined that improvements were needed to make Breakneck Road safer to travel, for both motorists and pedestrians; and

**WHEREAS**, in order to enable these improvements to be made, the Club and some of its individual members conveyed certain portions of various properties located along Breakneck Road to Vernon Township in 1985 and 1986; and

WHEREAS, as additional consideration for these transfers, Vernon Township agreed to waive and forego enforcement, against the Club and its current and future individual members, of certain snow and ice removal, maintenance, replacement, improvement and repair obligations for the soon to be constructed municipal sidewalks abutting these properties. However, this agreement was not reduced to writing at that time; and

WHEREAS, since that time, as new municipal officials have taken office and the institutional memory regarding this agreement has faded, there have been at least three distinct efforts to compel the removal of snow and ice from the sidewalks abutting Breakneck Road. Most recently, a new sidewalk maintenance Ordinance 18-20, enabled by <u>N.J.S.A.</u> 40:65-12 ("Sidewalk Debris Statute"), was proposed by Vernon Township, and opposed by the Club and its current and future individual members as to these Breakneck Road properties, based on the historical record; and

WHEREAS, in order to ensure that this problem does not arise in future, the Club is now recording a Corrective Deed, incorporating this Agreement between the Club and Vernon Township, as to the properties that it conveyed to Vernon Township in 1985 for the improvements along Breakneck Road. Vernon Township has agreed to sign this Corrective Deed to indicate its acceptance and consent thereto; and

**WHEREAS,** the Club and Vernon Township intend that the individual property owners who also conveyed property to Vernon Township at that time be made third party beneficiaries of this Agreement, which is to inure to the benefit of current and future individual property owners; and

**WHEREAS**, the Club and Vernon Township now wish to confirm and memorialize this Agreement, for the benefit of the Club and its current and future individual members, who are third party beneficiaries to this Agreement.

**NOW, THEREFORE,** it is hereby resolved that Vernon Township agrees to not adopt any ordinance or resolution that imposes any obligation on the Club and its current and future individual members allowed by the Sidewalk Debris Statute for any sidewalks that abut Breakneck Road. A copy of the Resolution passed by the Vernon Township Council, dated \_\_\_\_\_\_, 2019, accepting the Corrective Deed, and authorizing and reaffirming this Agreement is attached hereto.

**IN WITNESS WHEREOF**, the Club and Vernon Township have caused this Agreement to be signed and notarized as of the date as set forth herein.

Council President Murphy read the title and asked for a motion to Introduce Ordinance #19-25 with a Public Hearing on December 9, 2019.

Council Member Curreri questioned where specific regulation in the Short Term Rental Ordinance regarding foster home properties originated. Mayor Shortway explained proposed Ordinance verbiage came from collaboration from many sample ordinances and reason it was added was for protection for the Township. Council Member Curreri stated as being a former foster home, there are times that a licensed facility may not have a child placed and noted the unfairness of the restriction. Attorney Townes explained the emphasis of the Short Term Rental Ordinance was to regulate Airbnb's and similar entities and would be a policy decision to not allow it in residential units. Council Member Curreri also noted other communities in California and Jersey City have stricter regulations and further expressed insurance concerns which have not yet been discussed. He added that residents have commented they don't want a revolving door in their neighborhood. Mayor Shortway commented

that Short Term Rentals already exist in Vernon and it is impossible to see every unintended consequence but noted amendments can be made in future should Council decide.

Council Member Curreri made a motion to remove the term foster home from the section 476 - 4 (B) in Proposed Ordinance #19-25.

Scott Geysels, Barry Lakes, commented that on page 5 of Short Term Rental Ordinance, the section of permitted properties included condominiums and town home associations but had no reference to Lake Associations. Mayor Shortway explained he has spoke to the Township Attorney and the omission was an oversight and can be amended before adoption. Council President Murphy questioned if Council can amend Ordinance tonight which Attorney Townes stated a Motion for Reconsideration must be approved for this action.

#### **MAYORS REPORT**

Mayor Shortway commented he attended a seminar at the League of Municipalities Convention about benefits of increased jobs, income in the Urban Enterprise Zone and expressed hope Vernon will have similar positive affects if Highlands Enterprise Zone is approved. He noted smaller communities in Sussex County like Hamburg and Branchville may not be supportive of such a measure.

Mayor Shortway reported that West Milford has filed a complaint for lack of compensation from the water taken out of the area and the loss of development rights from the Highlands Act. He suggested the complaint is a reasonable argument and Vernon may want to join with West Milford in this effort. Council President Murphy noted the issue of protecting the water is important and questioned if the state ultimately owns the water supply. Mayor Shortway explained that commercial businesses do not want to pay extra for water supply from the Highlands, but legislators have to consider fairness to our area.

#### **COUNCIL COMMENTS**

Council Member Auberger made no comments.

Council Member Van Tassel made no comments.

Council Member Curreri requested a status update on the Silver Spruce issue. Mayor Shortway explained it has been assigned receivership and may takes years for issue to be resolved. He suggested to Mayor Elect Burrell to consider budgeting for Environmental Attorney for remediation efforts. Council Member Curreri expressed thanks to all First Responders for their service to our community.

#### COUNCIL PRESIDENT COMMENTS

Council President Murphy questioned if the liens from Ordinance approving the Mountain Creek Agreement have been recorded with Sussex County. Council President Murphy noted that Clerk Lauren Kirkman's last day will be December 6, 2019 and thanked her for her years of service to the Township.

Council President Murphy commented the Township received an OPRA request for payroll records and expressed concern with the paperwork provided. She expressed concern with potential litigation since prior requests of this nature have been produced by our contracted payroll company and urged Administration to follow up with request.

#### ADJOURNMENT

There being no further items of business to be conducted on the agenda, a motion for Adjournment was made by Council Member Auberger and was seconded by Council Member Van Tassel with all members voting in favor.

The Regular Meeting of the Township Council of the Township of Vernon was adjourned at 7:31 p.m.
