The Meeting of the Township Council of the Township of Vernon was convened at 7:30 p.m. on Monday November 27, 2017 in the Vernon Municipal Center, 21 Church Street, Vernon, New Jersey with Council President Jean Murphy presiding.

#### SALUTE TO THE FLAG

Council Member Murphy led the assemblage in the salute of the flag.

Council President Murphy asked for a motion to open the meeting to Public Comments.

MOVED: Dan Kadish SECOND: Sandra Ooms All members voted in favor.

Anthony Horler questioned the status of sale of specific township owned property that he is interested in purchasing. Mr. Horler commented, as a Barry Lakes resident, the homeowner's association By-laws and the Township code lacks definition of who is responsible for the maintenance of road drainage, and of swale and ditches along roads in the lake community. Mr. Horler states the Township should provide explanation in writing to the association so the Lake By-Laws can be amended. Council President Murphy told Mr. Horler to contact Administration for assistance.

Joseph\_(name unclear), \_\_\_\_\_\_ commented the Township zoning ordinance states recreational vehicles must be put in rear or side yard which is difficult in many lots in Vernon Township and asked if Zoning Officer can review ordinance for relief to residents. Joseph provided written information to Mr. Voelker.

Mr. Voelker explained that Resolution #17-212 is to authorize cancellation of unused funds that were budgeted for the 2017 Gypsy Moth Suppression Program and added the State recently performed an egg mass survey and found no spraying would be recommended in 2018.

Seeing no further members of the public wishing to come forward, Council President Murphy asked for a motion to close the meeting to Public Comments.

#### **MAYOR'S REPORT**

Mayor Shortway commented that Vernon Township received the Bronze Certification from Sustainable NJ for the second year in a row.

Mayor Shortway commented a donation from Mitch Morrison, 100 Thanksgiving meals were distributed to needy seniors and congregants of Vernon Methodist Church and expressed thankfulness to all volunteers involved.

Mayor Shortway thanked the Sheriffs Labor Assistance Program (SLAP) for their help on November 19. 2017 clearing a trail along with the Recreation Board members and the Vernon Running Club. He added the \$2,000 grant received will be used to blaze the walking trail from the Police Athletic League property.

Mayor Shortway thanked the volunteers from the McAfee Fire Department who assisted the Beautification Committee with hanging the lighted Snowflake decorations in the Town Center. Mayor Shortway announced the Township Holiday Tree Lighting will be held on December 1<sup>st</sup> at the Vernon Firehouse at 6:30 pm and encouraged residents to attend to bring the Vernon community together.

**WHEREAS,** N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

**WHEREAS**, said Director may also approve the insertion of an item of appropriation for an equal amount; and

**WHEREAS,** the Township has been awarded a \$12,265.89 Drunk Driving Enforcement Fund Grant from the New Jersey Department of Law and Public Safety Division of Highway Traffic Safety; and wishes to amend its 2017 budget for this amount as a revenue.

**NOW, THEREFORE, BE IT RESOLVED** that the Township Council of the Township of Vernon hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year 2017 in the sum of \$12,265.89 which is now available as a revenue from the New Jersey Department of Law and Public Safety Division of Highway Traffic Safety and;

**BE IT FURTHER RESOLVED** that a like sum of \$12,265.89 is hereby appropriated under the caption Drunk Driving Enforcement Fund Grant.

**WHEREAS**, in a memo dated November 6, 2017, the Township Engineer states that the contract requires a Change Order #1 of two additions totaling \$245.70 and one reduction totaling \$168.00 resulting in an adjusted total contract amount of \$11,916.60; and

**WHEREAS**, the Township Engineer, in concurrence with the Mayor, recommends approving Change Order No. 1 which will increase the total contract amount by \$77.70 to an adjusted total contract amount of \$11,916.60.

WHEREAS, the term of the contract will be a 60 (sixty) month lease beginning December 2017 and cost will not exceed \$3,635.16/ annually.

WHEREAS, the Chief Financial Officer has certified that funds are available for this purpose in the 2017 budget and is subject to approval in 2018-2022 Municipal Budgets.

Mayor Shortway added that there are businesses expanding who are selling farm products.

Ms. Kirkman explained that the governing body does not determine farm assessment and the Resolution is to allow Farmland Preservation status which is a voluntary program. Council Member Kadish added there are less than 10 farms left in Vernon.

#### ITEMS FOR DISCUSSION

Vernon Township's Bills on Council Meeting Agenda

Mr. Townes, Township Attorney, stated a resolution to have the Township's bills list on the Council Agenda for vote would not be appropriate. Per litigation in 2014, the decision stated it is not in the Council's purview to approve or disapprove bills as bills are paid by the Mayor. He added the Court held there is no requirement for the bills list to be on the agenda. Mr. Townes commented that past litigation expenses were spent on this issue and he stated he would not recommend adopting such a measure.

Council Member Ooms disagreed with the Attorney's determination and added it is fiscally irresponsible and it is the Council's responsibility to monitor how Township funds are spent. She added Council should vote on the bills list.

Council Member Ooms provided an example of a bill for the Faline Building appraisal and opined the service was not provided satisfactorily in her opinion so the Township should not have paid the bill. Council Member Kadish stated that Vernon did receive a response from the appraisal which said the building is not worth the assessed value. Council Member Rizzuto added the appraisal was in April, but Mayor did not provide it to Council until September.

Council Member Kadish explained that bills must be processed within thirty (30) days and should a Council meeting be cancelled; vendor payments would be delayed. Council Member Rizzuto stated that he agrees that bills should be on Council agenda for vote. Council Member Ooms added examples of towns that require Council vote on the bills list: Manchester, Ewing and Long Branch.

Council Member Ooms made a motion for Bills List to be put on agenda for Council approval.

#### **COUNCIL COMMENTS**

Council Member Ooms stated that a Resolution was prepared stating Council approval will be needed prior to applying for any Grants. Mr. Townes explains that as previously told to Ms. Ooms, this action infringes on the administrative powers of the Mayor. Council Member Ooms asked if the grant requires a Council vote, the vote should be done before an application submitted.

Ms. Kirkman explained grants are sometimes released with a brief window for approval, require hard work to complete and allow for submission of grant with Council approval at later time. If Council disapproves of grant resolution, the state would then disqualify the application. Council President Murphy commented review of application would be micromanaging and the time frame does not always allow a vote ahead of time. She added that all Council have the opportunity of asking Mayor and Business Administrator for information when the Agenda packet is received and prior to the meeting so paid Consultants are not needed.

Council Member Rizzuto had no comments.

Council Member Wetzel had no comments.

Council Member Kadish has no comments.
