This Meeting of the Township Council of the Township of Vernon was convened at 7:20 p.m. on November 28, 2022 via Zoom Webinar and in the Vernon Municipal Center, 21 Church Street, Vernon, New Jersey with Council President Patrick Rizzuto presiding.

### STATEMENT OF COMPLIANCE

#### SALUTE TO THE FLAG

Council President Rizzuto led the assemblage in the salute to the flag.

### **REVIEW OF BILLS LIST**

The Council reviewed the bills list.

#### MAYOR COMMENTS

At our October 13 Council meeting, I announced that our Municipal Judge, the Honorable James Devine, had provided me his letter of resignation, effective at the end of this year. Judge Devine will be resigning, and moving on to a well-deserved retirement, one year before his latest three-year term ends. I requested that the Council approve my appointment of a new judge to serve Vernon for the one-year period of Judge Devine's unexpired term, and I thank them for approving my request. The Council approved my nomination of the Honorable Judge JAMES P. SLOAN to be the Vernon Municipal Court Judge for the period January 1 – December 31, 2023 - - that is, for the unexpired term of Judge Devine.

I thank the Council for its approval for me to execute a shared services agreement between the Township of Vernon and the Vernon Township School District. This shared services agreement will enable our School District to directly source all of the gasoline and diesel fuel that they need for their vehicles, from the municipality's new state-of-the-art fueling station. In addition to providing School District vehicles 24/7 access to needed fuel, this agreement will result in our School District being able to significantly save on the cost of fuel.

One of the things of which I am very proud, is the way in which the Office of the Mayor has worked close with our Mayor's Wellness Campaign Team to reach out and serve all segments of the Vernon family. Vernon's Mayor's Wellness Campaign Team is headed by our Director of Recreation & Community Affairs, Ms. Mishelle Downtain, with the very capable and ever-present support of her Assistant, Ms. Meg Wahnon. The Mayor's Wellness Campaign Team and I have committed ourselves to ensuring that Vernon does not leave any member of the Vernon family behind; and this year, we are launching a new program during this holiday season to reach out and meet the needs of our Vernon family members who process sensory information in a different manner than their neurotypical peers. Specifically, this year, just before the larger, louder, and activity filled 6pm lighting of the Municipal Holiday Tree on the lawn of the Vernon Fire Department Building, we will join with the PAL and the Vernon Board of Recreation to host a 5pm Sensory Friendly Quiet Time with Santa in the Municipal Senior Center.

WHEREAS, the Township Council of the Township of Vernon adopted a resolution (#R18-35) on April 13, 2018 designating various lots in the TC Zone and adjacent parcels as non-condemnation area in need of redevelopment pursuant to the Act; and

WHEREAS, Resolution No. 18-35 was transmitted to the Commissioner of the State of New Jersey, Department of Community Affairs, and the area in need of redevelopment designation became effective on or about May 10, 2018; and

WHEREAS, the Township Council adopted the Redevelopment Plan as Ordinance 21-10 on April 26, 2021; and

WHEREAS, a property within the TC Redevelopment Plan Area requested amendments to the Redevelopment Plan to assist in their operations and future expansion; and

WHEREAS, the Local Housing and Redevelopment Law permits amendments to Redevelopment Plans over time to meet the demands of the marketplace; and

WHEREAS, the Township Council wishes to utilize the experience and expertise of the Land Use Board to review and provide comments on the proposed amendments as well as review the amendments for consistency with the Master Plan;

NOW, THEREFORE BE IT RESOLVED, by the Township Council of the Township of Vernon as follows:

### I. GENERAL

The aforementioned recitals are incorporated herein as though fully set forth at length.

II. LAND USE BOARD DIRECTED TO REVIEW AND COMMENT ON THE ATTACHED DRAFT REDEVELOPMENT PLAN AMENDMENT INCLUDING A REVIEW OF CONSISTENCY WITH THE MASTER PLAN.

#### **ORDINANCE #22-23**

## ORDINANCE OF THE TOWNSHIP OF VERNON, COUNTY OF SUSSEX, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 509, ARTICLE II ENTITLED "CANNABIS TAX" TO DEDICATE CANNABIS TRANSFER TAX PROCEEDS FOR THE REPAIR AND MAINTENANCE OF TOWNSHIP ROADWAYS

**WHEREAS,** on July 26, 2021, the Township Council of the Township of Vernon ("Township Council") passed ordinance No. 21-16 which authorized cannabis cultivation, cannabis delivery, cannabis manufacturing, cannabis wholesaling, and cannabis distribution in the Township of Vernon ("Township")

WHEREAS, on August 23, 2021, the Township Council passed ordinance No. 21-24 which imposed a transfer tax of 2% on receipts from the sale of cannabis by a cannabis cultivator to another cannabis cultivator; receipts from the sale of cannabis items from one cannabis manufacturer to another cannabis establishment; and receipts from the retail sales of cannabis items by a cannabis retailer to retail consumers who are 21 years of age or older; and a tax of 1% of the receipts from each sale by a cannabis wholesaler; and

**WHEREAS**, the Township is always seeking new ways to improve its infrastructure and to reduce the tax burden on its residents; and

**WHEREAS**, a determination has been made that it is in the best interests of the Township to dedicate a portion of the transfer tax proceeds to pay for repair and maintenance of the Township's roadways.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Township of Vernon, County of Sussex, and State of New Jersey, that Chapter 509 is amended and supplemented as follows:

# **SECTION 1**

### § 509-11.1. Dedication of Transfer Tax Funds for Roadway Repair and Maintenance.

50% of all cannabis transfer tax funds imposed in § 509-11 and received by the Township shall be dedicated in a separate account to be used for roadway repair and maintenance costs in the Township.

# **SECTION 2**

Each section of this ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective for any cause shall not be deemed to affect the validity of constitutionality of any other sections or parts thereof.

## **SECTION 3**

Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

## **SECTION 4**

That this ordinance shall take effect upon final passage upon expiration of twenty (20) days following publication unless otherwise provided.

There is unrepairable damage to the dam causing the lake to be drained substantially.

Liz Gates - Lake Wanda, also spoke in reference to Lake Wanda and the problems Hurricane Ida caused to the dam and the lake.

Steve Dunlop – Williamsville Estates, hopes that the Council and Mayor can work together. He is concerned about Mr. Voelker's contract because of the number of sick days he was given.

Shawn Mazur – Vernon Township, commented on a letter he received from Attorney Zielinski because he feels the letter is harassment.

Jessica Paladini – Vernon Township, agrees with Steve Dunlop in reference to Mr. Voelker's contract. She welcomed Joe Tadrick to the Council. Ms. Paladini received a letter from an elderly woman who needed help because no one from the township helped her in the past.
