WHEREAS the Township of Vernon has agreed to the establishment of a Length of Service Award Program (LOSAP) Deferred Compensation Plan. This plan is to be made available to all bona fide eligible volunteers who are performing qualified services which is defined as fire fighting and prevention services, emergency medical services and ambulance services pursuant to Section 457 of the Internal Revenue Code of 1986, as amended, except for provisions added by reason of the Length of Service Award Program as enacted into federal law in 1997. WHEREAS, the Township of Vernon deems it appropriate to act to ensure retention of existing members and to provide incentives for recruiting new volunteer firefighters/first aid organization members; and

WHEREAS, the Township of Vernon has a Length of Service Award Plan Document that implements the Programs objectives; and

WHEREAS, certain tax benefits could accrue to eligible volunteer firefighters' organization members;

NOW THEREFORE BE IT RESOLVED that the Township of Vernon is adopting a Length of Service Award Program Deferred Plan which is substantially similar to a Plan that has been submitted to the Internal Revenue Service for a Private Letter Ruling. The use of the Ruling is for guidance only and the Township of Vernon acknowledges that for Internal Revenue Service purposes, the Ruling of another sponsoring agency is not to be considered precedent; and

WHEREAS, the sunset provision of March 1, 2025 imposed under P.L. 2024 c.106 is fast approaching in what was a temporary solution that allowed local governments to comply with the public notice requirements under the law in time for annual reorganization meetings in January; and,

WHEREAS, local government officials serve as the stewards of property taxpayer dollars and should no longer be required to subsidize the newspaper industry with revenues collected from publishing legal notices in the press; and,

WHEREAS, long before NJ Advanced Media's announcement that it was terminating daily print publications in January of 2025, local government officials found it increasingly difficult to comply with the public notice requirements under the law as the media has become almost exclusively digitized and struggled to retain staff, resources, and publications; and,

WHEREAS, legislation that will authorize local governments to publish legal notices on a local government's official website will streamline an antiquated and overly burdensome process and save valuable time, resources, and property taxpayer dollars; and,

NOW, THERFORE, BE IT RESOLVED that Township of Vernon does in

fact, hereby urge state leaders to pass legislation that will authorize municipalities, counties, school districts, and all local governments to publish legal notices in a clear, transparent, and timely manner on a local government's official website.

BE IT FURTHER RESOLVED that a copy of this Resolution shall be sent to Governor Phil Murphy, Senate President Nicholas Scutari, Speaker of the General Assembly Craig Coughlin, Senator Parker Space, Assemblymembers Dawn Fantasia and Michael Inganamort and the New Jersey State League of Municipalities.

WHEREAS, in the 25 years of the existence of the County program, the County has preserved in excess of 19,425 acres of farmland and 4,845.3 acres of open space, these accomplishments being achieved in cooperation with municipal, state, and private partners; and

WHEREAS, both prior public authorizations provided for the expiration of the authorization after a period of 10 years, with the November 2000 authorization expiring on January 1, 2011, the 2005 authorization scheduled to expire on January 1, 2016, and the 2015 authorization scheduled to expire on January 1, 2025; and

WHEREAS, there still exists a significant need for Farmland and Open Space preservation in Sussex County; and

WHEREAS, in the absence of a stable source of funding, land preservation efforts within Sussex County will cease;

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Vernon, in the County of Sussex, State of New Jersey, as follows:

We call upon the Board of Chosen Commissioners to adopt the necessary resolution pursuant to the provisions of N.J.S.A. 40:12-15-15.2, to authorize a public referendum to appear on the November 4, 2025, general election ballot to seek voter approval to continue the Sussex County Farmland Preservation, Recreation, and Open Space Trust Fund for an additional 10-year time period.

BE IT ORDAINED by the Governing Body of the Township of Vernon, in the County of Sussex, New Jersey, that the following capital projects be hereby authorized but not limited to include acquisition and installation of computer equipment and improvements for the Police Department; for a total Improvement Authorization of \$55,000.00.

BE IT FURTHER ORDAINED that the financing for the above projects be as follows:

General Capital Reserves- Police Department \$42,000.00 General Capital Improvement Fund \$13,000.00

BE IT FURTHER ORDAINED that the capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget and capital improvement program as approved by the Director, Division of Local Government Services, are on file with the Township Clerk and are available for public inspection.

BE IT FURTHER ORDAINED that the period of usefulness of the capital projects are in excess of the five (5) year statutory requirement, and that no debt shall be incurred by the Borough for this authorization. This ordinance shall take effect immediately upon final passage and publication as required by law.

PUBLIC COMMENTS (Limited to 5 Minutes Per Person)

President Rizzuto asked for a motion to open the meeting to Public Comments.

MOVED: Sparta SECOND: Higgins

All members were in favor.

Seeing no members of the public wishing to speak, President Rizzuto asked for a motion to close the meeting for Public Comments.

MOVED: Sparta SECOND: Higgins

All members were in favor.

Motion carries to close the floor to public comments.

COUNCIL COMMENTS

Council Member Higgins had no comments.

Council Member Sparta commented that State Assemblyman, Mike Inganamort introduced a small-town rescue plan that would reimburse towns for Sate mandated property tax refunds. It's going to directly benefit towns by increasing State aid, which would ultimately allow municipalities to lower property taxes for their residents. Council Member Sparta appreciates Assemblyman Inganamort's efforts

Council Member Sparta called the police non-emergency number to report a tour bus on Route 515 and the Vernon Police turned the bus around and sent him back the right way. Council Member Sparta encourages people to call the non-emergency police number if they see anything like this in the future. He feels that there should be a heftier fine and more signage for the speed limit and weight limit.

Council Member DeBenedetto had no comments.

COUNCIL PRESIDENT COMMENTS

Council President Rizzuto commented on the cost for legal notices that the township has to advertise. He feels that if we could get the passage of having legal notices on our website instead of the newspaper, it would save the town a substantial amount of money and time.

Council Member Higgins asked about the budget process.

ADJOURNMENT

At 8:20 pm Council Member Sparta made a motion to adjourn the meeting. Seconded by Council Member Higgins.
