2025 Municipal Budget

MAYOR COMMENTS

Mayor Rossi explained that in this year's budget, we are forced to deal with and recognize not only this year's inflationary costs, but also the inflationary costs of 2022 through 2024, which include the following:

- 1. Over 21% in Health Insurance expenses.
- 2. Over 26% in Liability Insurance increases.
- 3. Over 28% in Worker's Compensation Insurance.
- 4. Over 37% in Road Repairs/Maintenance Other Expenses/Operations.5. Over 30% in Buildings and Grounds Other Expenses/Operations.
- 6. Over 89% in Recycling Operations/Other Expenses for recycling disposal.
- 7. Over 31% in Police Operations/Other Expenses for service contracts.
- 8. Over 27% for Fleet Maintenance Other Expenses for maintaining the Township fleet and emergency service vehicles.
- 9. Over 9% increase in budgeted utilities expenses.
- 10. Over 16% in Social Security expenses.
- 11. Over 38% in Pension obligations for public employees.
- 12. Over 28% for Pension obligations for police employees.
- 13. Over 11% in capital expenditure increases for cash capital expenses on short-lived capital items.

Council Member Sparta feels that we can replenish our surplus with the back taxes from Legends. Council Member Sparta would like the Council to take action against Legends to get the back taxes paid. He would like to see a resolution on the May 12, 2025 agenda if nothing is done by the end of April.

Council Member Buccieri echoes Council Members Higgins and Sparta comments tonight. She wishes everyone a nice Easter.

COUNCIL PRESIDENT COMMENTS

Council President Rizzuto would also like to see the progress on the Legends property by the time period that was given. He feels that if this is not done within the time period given, the Council will have to move in a different direction with the property.
