Ms. Distasi also commented that the bond ordinance is totally irresponsible at this time. She does not believe it should be passed. Ms. Distasi is concerned about the \$900,000 for the pump track because this was not supposed to cost taxpayers any money.

Veronica Castner – Vernon Township, asked if there is an approved plan for the bond as far as the pump track.

Matt McConway – Vernon Township, he feels that when the pump track was talked about years ago it was not supposed to cost the tax payers any money and was supposed to be done by volunteer work. He said he emailed the Mayor and Council because he had someone who would build the pump track for free but no one responded to him.

Natalie Buccieri – Vernon Township, does not know if there are RFPs for the pump track. She feels we are creating a budget without RFPs. She feels this is a lot of money and something the town cannot afford right now and more research should be done.

"BVP is a critical resource for state and local jurisdictions that saves lives. Based on data collected and recorded by the U.S. Department of Justice, in FY 2012, protective vests were directly attributable to saving the lives of at least 33 law enforcement and corrections officers, in 20 different states, an increase 13.7% over FY 2011. At least 14 of those life-saving vests had been purchased, in part, with BVP funds." (OJP website, U.S. Department of Justice 2013) This grant is committed to officer safety; and

**WHEREAS**, Vernon Township will incur the cost of the program, not to exceed \$11000.00 and then submit the necessary documentation to the U.S. Department of Justice for a fifty percent (50%) reimbursement.

#### INTRODUCTION/1ST READING OF PROPOSED ORDINANCE

\*\*\*\*Council President Shortway entered the meeting at 7:30 pm.

<u>Ordinance #21-12:</u> Bond Ordinance Appropriating \$4,015,000, and Authorizing the Issuance of \$3,130,000 Bonds or Notes of the Township, for Various Improvements or Purposes Authorized to be Undertaken by the Township of Vernon, in the County of Sussex, New Jersey

Council Vice President Auberger read by title Ordinance #21-12.

Council Vice President Auberger asked for a motion to introduce Ordinance #21-12.

Council Member Pitsker asked if the itemized spreadsheets the Council received could be on the agenda for the next meeting. He said the average homeowner will pay about \$32.00 a year. This is an investment in mostly capital equipment as well as track and trail. Council Member Pitsker asked if our debt would actually shrink with this bond.

CFO Bright clarified that the total on the bond ordinance is \$4,015,000 the actual debt authorized is \$3,130,000. The majority of the bond is for capital areas in the Township. Our total debt last year was 1.072% with this bond ordinance it is 1.070% because we have paid down debt already this year. So even with the increase of this \$3,130,000 we will still see a decrease in our overall debt.

Council Member Cilli asked if this will raise peoples' taxes.

CFO Bright said this will not raise peoples' taxes. She explained that a bond ordinance authorizes you to take out a debt. This does not mean I go and take out a \$3,000,000 loan from the bank. Ms. Bright said part of her job as the CFO is to do cash management. She is not going to take out a loan tomorrow. It will be based on when these projects are going to be finished and what the interest rate is at the time. It will be based on what is best for the town.

Council Member Pitsker said the actually portion of the pump track comes out to \$5.80 per household.

Council Member Weller said that there are road improvements in the pump track portion as well.

CFO Bright explained that when you are reading the bond ordinance a large portion is for road improvements. Road improvements need to be made on Black Creek Drive and there is also a proposed road with access on Omega Drive. These are proposed projects and we have not gone out to bid on them, these are estimated from our Township Engineer. CFO Bright said if we come under the estimates, we will cancel the debt.

Council Member Cilli said we have bonded or went out for debt in 2011 \$3.8 million for Great Gorge sewer and \$2.06 for SCUMA for 5 years of payment. Council Member Cilli commented that this ordinance is for the roads, an ambulance, things for the fire department and to fix Maple Grange. This ordinance is not just for the pump track. This is something that is good for our town.

Council President Shortway commented that we are also looking at the fuel tank. He spoke about this when he was Mayor, with Baldwin Fuel moving the town was going to go to its own fuel filling station. This will cost about \$225,000. This is another major improvement to township properties.

Administrator Voelker said this will lead to a possible shared service with the Board of Education.

Mayor Burrell commented that we need to invest in our town. The last time we invested in the town was Main Street. These are smart investments that we thought about a great deal. It will be a good shared service agreement with the BOE when Baldwin Fuel goes out. We have had people ask us about electric charging stations and we will look at this as a possibility. Mayor Burrell feels that this will be a major plus for our town. Interest rates are low and we would be foolish if we did not get the permission to this right now.

Council President Shortway also mentioned the lighting at Veterans Memorial Park is about 40 years old. In 2019 the line blew and there was fire on a pole with children present. Things break and wear out and we have to go forward. Council President Shortway said we do not want to repeat what happened at the Maple Grange fields when they were closed down and not replacing and this is another \$350,000. This is an investment in our total community

Council Member Cilli asked if there would be a presentation for the pump track and trails for the public.

Mayor Burrell said yes, we will most likely have a special town meeting We will have some renderings of what the town will look like in the future as well as estimates on costs. We will be doing this hopefully very soon.

#### PUBLIC COMMENTS (Limited to 3 Minutes On Any Topic)

Council Vice President Auberger asked for a motion to open the meeting for Public Comments.

MOTION: Andrew Pitsker SECOND: Kelly Weller

All members were in favor.

Al Losco - President of Glen Harbor Homeowners Association emailed saying, I would just like to follow up on the shooting incident that was discussed at the last meeting. Are there any updates? Thank you for your concern.

Mayor Burrell said he returned a call to Mr. Losco this morning but got no answer and he left a message.

Jessi Paladini – Vernon Township, feels that the sewers have nothing to do with borrowing to do regular maintenance that a town needs to do and we had no choice with the sewers. Ms. Paladini feels that we should be using set aside capital improvement funds and these projects should be a pay-as you-go.

Peg Distasi – Vernon Township, agrees with 90% of the town improvements. She is opposed to spending \$900,000 to build a trail and pump track at taxpayers' expense. Ms. Distasi said they were told that none of this would cost the taxpayers any money. She agrees that there should be a capital fund created and asked that the Council does not put the town into further debt. She feels that roads, fire department and an ambulance are necessary vehicles and expenses but a trail and pump track are not. Ms. Distasi is glad to hear that the Mayor will hold a public meeting and we will hear some facts.

Walter Marsico – Vernon Township, quoted the Mayor's comments from the April 26<sup>th</sup> meeting that he found disturbing. Mr. Marsico said the Mayor works for the taxpayers and business owners and whether good or bad he should be addressing issues. Mr. Marsico feels that the town's administration is on a witch hunt to intimidate him and his family and no one has returned his phone calls or emails. Mr. Marsico is trying to build a house and feels that he is being attacked. He said the town is trying to get COAH payments from him that he feels he is exempt from.

Natalie Buccieri – Vernon Township, asked if the Council has discussed going back to in person meetings and if so, what is the timeline.

Beverly Marsico – Vernon Township, asked why no one could respond to Mr. Marsico emails for the harassment and extorsion of money.

Council President Shortway remarked that point of order, Mr. Marsico already spoke.

Council Vice President Auberger allowed Mr. Marsico to speak a second time.

Walter Marsico – Vernon Township, asked who from the Township Administration is driving by at night in a personal vehicle and photographing his house whether anyone lives there or not. He finds this disturbing. He feels that this is why the town has no new construction.

Seeing no other members of the public wishing to speak, Council Vice President Auberger asked for a motion to close the meeting for Public Comments.

All members were in favor.

#### MAYOR COMMENTS

In my February 8, 2021 Mayor's Report, I advised the Council and the public that the town had successfully cleaned up the debris field to which the New Jersey DEP had been directed by Mr. Joe Wallace and those who have chosen to use their Facebook pages to partner with him.

Mr. Wallace is the infamous individual that Vernon residents, and most in the tristate area, know very well as a result of the unfortunate negative national news coverage that our town received from the illegal toxic waste mountain that Mr. Wallace created in the Silver Spruce Drive area of our town. I also shared the fact that the Mayor's Office had informed the New Jersey DEP of our successful debris field cleanup, and had invited them to come to our town and review and inspect our work.

The DEP accepted our invitation, and made their inspection visit on this past April 13.

The following are the two key DEP conclusions that resulted from that April 13 visit:

CONCLUSION # 1: After a detailed and in-depth inspection, the DEP concluded that our debris field cleanup effort was thorough and complete.

CONCLUSION # 2: This conclusion came as a result of the fact that the DEP advised that a few Vernon residents had repeatedly claimed that there was toxic solid waste buried all over this piece of town property.

This is a large piece of town owned property, with a small portion being occupied by our Department of Public Works' Temporary Storage Facility, and another small portion being the location where we plan to build a Municipal Pump Track.

As a result of these repeated claims by a few Vernon residents, the DEP chose to dig test pits in eight distinct different locations over the entire property, as part of their efforts to confirm once and for all, if there was or if there was not, toxic solid waste buried on this property.

To ensure that the test pits would be sufficient to reveal any toxic solid waste that might be buried on this property, at the DEP directions, our Department of Public Works crew dug test pits that were 8-10 ft deep; 5-7 ft wide; and 8-10 ft in length.

This second conclusion by the DEP, was that not a single test pit revealed any solid waste, toxic or non-toxic, buried on this property.

With these two positive conclusions from the New Jersey DEP, the Mayor and Council will now proceed expeditiously with specific actions that are required to make a Municipal Pump Track a reality. Now I understand that these two key conclusions from the New Jersey DEP will not appeal to, or even be accepted by, those who have been the authors of the angry, negative, and misleading frequent Facebook posts claiming that this property was nothing but a "toxic waste dump".

However, now that the truth has been confirmed by the State Department of Environmental Protection, I issue this invitation to those residents who might have been misled by these angry, negative, and misleading frequent Facebook posts often filled with half-truths - -

I invite them to join with the Mayor and Council, and the great majority of other Vernon residents, as part of the unified team that's working together to MOVE VERNON FORWARD. We want and need them to become part of the VERNON STRONG team!

This open and factual approach that the Mayor and Council has taken to addressing this claim of a "toxic waste dump", is but just the latest example of the Mayor and Council working together to do our due diligence, so as to ensure that we do the right thing for our town and its residents.

#### **COUNCIL COMMENTS**

Council Member Weller reminded everyone that the first farmer's market is scheduled for May 22, 2021. This has been a great event in the past and she encourages everyone to attend. There are over 20 venders which is more than we have ever had.

Council Member Cilli commented that the cost of the trail keeps being bought up as \$900,000 but \$425,000 should go to the roads. Therefore, the trail would only use \$475,000 and this still needs to go out to bid.

CFO Bright explained that a large portion of that will be taken from the Open Space Fund. The whole project cost is in the bond ordinance which is \$900,000 and \$291,000 was approved in the referendum.

Andrew Pitsker commented saying that Councilman Auberger and myself had the opportunity to visit with the DPW on Thursday April 29 to tour the DPW garage and see the new Road Mower Purchase. I was concern with the amount of money we spend on such equipment and wanted to make sure we as taxpayers are getting our monies worth.

Ed Babcock and Pete Ribello took the time to show us the mower and other equipment and the importance of why these items are necessary.

I was very satisfied that not only are they buying the right equipment, but that they are getting the best value for the money.

I appreciate that Safety comes first and Mr. Ribello who specs out all of the Purchases for the DPW does a great job.

Thanks Ed & Pete for your time.

Regarding the Mayors comments on the DEP inspection of the DPW / Bicycle Pump track site. As I said in previous meetings and outings, we as stewards of the Town.

We are responsible for making this situation legally and morally right. This is a confirmation we take the publics concerns seriously and act in the proper and professional manner that brings resolution to all involved.

I hope we can complete the process in short time and move on to the next phase of doing something progressive for Town Center

Regarding the Bond Ordinance 21-12, I agree, this a big. But the investments in Capital equipment and our town infrastructure of the Track & Trail is important and financially doable. In my review and lots of questions regarding our investments, I feel it is time we make these investments if Town Center is going to have some revitalization. Town Center has laid fallow for too long.

When it comes to the BPT and the trails, I see this as an investment in our town center. When was the last time, we have made a serious investment other than Water and Sewer? If we are going to attract businesses to develop on Church street, which in my opinion has lied dormant for too long. We have to show we are serious about investing in our town. Albeit, this may not be the vision of some, but we are a recreational & destinations community for outdoor activities, so why not use that characteristic to help Vernon attract new opportunities.

This trail system has a future, if we think about it, we have the opportunity to connect to other communities in the future. Consider this, in Orange County NY, there is a Heritage Trail system that goes from Goshen to Harriman, 14 miles, and with that has come development and growth. Why can't we connect to Warwick and Hardyston, it is feasible... if we work together to find solutions We can do the same, but we have to start from somewhere. It is time we did something. I have lived here for 29 years, what have we done to invest in town center?

I believe this is one way. It is a solution, if you have solutions, please be part of the answer. If all you can do is complain, what value does that bring unless you have a solution and want to participate. Bringing communication, collaboration and cooperation together is how we get things done.

Additionally, I have been working with the administration and urge the mayor to present the plans, vision and answer the questions to the public, and I hope we can soon present the proposed BMP / Trail and the justification for doing so, I am for one trying to work toward viable, realistic solutions and being part of moving Vernon forward, but it takes time and we need to invest. Ordinance 21-12 is part of that and again, I support it.

Vice President Auberger elaborated with Council Member Pitsker about visiting the DPW and seeing the road mower that was purchased. He said a lot of research went into this vehicle and it should serve the town for a long time. Part of the cost was for extended warranties. This was really thought out and a job was well done on the purchase.

Vice President Auberger commented that a few weeks ago was opening day of Little League as well as the fishing contest at the firehouse and they were handing out tree saplings. He said it was really good to see the town back to being as normal as can be and people being nice to each other.

Vice President Auberger said he and the Mayor reached out through the Recreation Committee to the VFW because the State is allowing parades again. Whether the parade happens or not the VFW will still be having their ceremony on Memorial Day so he hopes people come out.

#### COUNCIL PRESIDENT COMMENTS

Council President Shortway had no comments.

#### **ADJOURNMENT**

There being no further items of business to be conducted on the agenda, a motion for adjournment was made by Council President Shortway, seconded by Council Member Weller with all members voting in favor.
