The Regular Meeting of the Township Council of the Township of Vernon was convened at 7:00 p.m. on May 24, 2021 via Zoom Webinar in the Vernon Municipal Center, 21 Church Street, Vernon, New Jersey with Council President Harry Shortway presiding.

Kevin Duffy - Chief Operations Officer Glenwood Pochuck Volunteer Ambulance Corps sent an email saying, on behalf of the Glenwood Pochuck Volunteer Ambulance Corps and its members, we once again can't thank the council enough for the consideration of the new ambulance. The new ambulance will be replacing one that has been in service for 18 years. With the council approval, the new ambulance will be 100% identical to the one purchased last year which has already been in rotation, received its first preventative maintenance by our township DPW and has responded to about 35% of our total EMS calls. Thanks to council and all our supporters, the added equipment has definitely made an impact on the service we provide and will continue to provide. Just like last year, Glenwood EMS will be swapping all our equipment into the new ambulance to not accrue additional costs to the township. Once more, on behalf of the entire membership of G.P.V.A.C, we thank each and every one of you for your continued support.

Ms. Distasi said that we would not have to spend over \$400,000 to put in access roads and pave Baldwin Avenue if the trails were not there. She feels between the roads, the trail and the Baldwin property the cost is \$1,000,000.

Jessi Paladini – Vernon Township, responded to Ms. Distasi saying the money for the Baldwin property will come from the actual Open Space tax. Ms. Paladini feels that Ms. Distasi is correct that the whole project will be in excess of \$1,000,000 or very close to \$1,000,000.

RESOLUTION #21-132 A RESOLUTION AUTHORIZING THE IMPLEMENTATION OF AN ACCIDENT & HEALTH POLICY FOR TOWNSHIP VOLUNTEERS

WHEREAS, the Township of Vernon routinely relies on the services provided by volunteers performing a variety of services that benefit the community and positively contribute to the fabric and core values of the Township; and

WHEREAS, said volunteers, are not eligible for benefits for injuries or sickness sustained with regard to their service as volunteers, as defined by the NJ State Workers Compensation Statute; and

WHEREAS, the Township's Risk Management Consultant has researched this issue and subsequently has recommended an Accident & Health Policy be secured, underwritten by Philadelphia Indemnity Insurance Company, (an *A.M. Best*, A-rated carrier) that provides a cost-effective means to cover this potential exposure.

WHEREAS, the Chief Financial Officer has certified funds not to exceed \$500.00 are available in Account #1-01-23-228-68 Insurance in the 2021 Municipal Budget.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Township of Vernon, County of Sussex, State of New Jersey that authorizes the Risk Management Consultant to secure an Accident & Health Policy to cover Township volunteers underwritten by Philadelphia Indemnity Insurance Corporation, for an annual premium not to exceed \$500; and

BE IT FURTHER RESOLVED, the Mayor and/or Township Administrator are hereby authorized to execute any and all documentation necessary to effectuate this coverage as soon as administratively practical; and

BE IT FURTHER RESOLVED, the contract award for said insurance product is to a duly licensed and admitted Insurance Company within the State of NJ and therefore, such award is exempt from the requirements set forth by P.L. 2004, Chapter 19 (as amended by P.L. 2005, c.51) N.J.S.A.19:44A-20.5 et seq.

Vice President Auberger said if you are changing the ordinance, it would be nice to know what the new rule book is.

Administrator Voelker said we are under the current handbook that we have had for over 10 years, so we have to utilize that for now.

Vice President Auberger said as a member of the fire department, he has never received the personnel policy handbook.

Administrator Voelker said it wasn't required by ordinance which is taking place here.

Council Member Cilli asked if they will have a copy of the handbook before the next meeting.

Administrator Voelker said he will make sure it is distributed whether paper or electronically.

Mayor Burrell said he will make sure in the future everyone gets a copy.

Administrator Voelker said with the new proposed handbook we will be required to have all fulltime paid employees and volunteers sign for receipt of the handbook, that they received and read it.

ORDINANCE #21-12

BOND ORDINANCE APPROPRIATING \$4,015,000, AND AUTHORIZING THE ISSUANCE OF \$3,130,000 BONDS OR NOTES OF THE TOWNSHIP, FOR VARIOUS IMPROVEMENTS OR PURPOSES AUTHORIZED TO BE UNDERTAKEN BY THE TOWNSHIP OF VERNON, IN THE COUNTY OF SUSSEX, NEW JERSEY.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF

VERNON, IN THE COUNTY OF SUSSEX, NEW JERSEY (not less than two-thirds of all the

members thereof affirmatively concurring), AS FOLLOWS:

Section 1. The several improvements described in Section 3 of this bond ordinance are hereby respectively authorized as general improvements to be made or acquired by The Township of Vernon, in the County of Sussex, New Jersey. For the said several improvements or purposes stated in said Section 3, there are hereby appropriated the respective sums of money therein stated as the appropriations made for said improvements or purposes, said sums being inclusive of all appropriations heretofore made therefor and amounting in the aggregate to \$4,015,000 including the aggregate sum of \$300,196, as the several down payments for said improvements or purposes required by law and more particularly described in said Section 3 and now available therefor by virtue of provision in a previously adopted budget or budgets of the Township for down payment or for capital improvement purposes and including also, in the case of the improvement or purpose described in (i) paragraph (b) of said Section 3, the sum of \$181,200 received or expected to be received by the Township from the New Jersey Department of Transportation as a grant-in-aid of financing said improvement or purpose, (ii) paragraph (d) of said Section 3, the sum of \$62,000 from various funds of the Township for the improvement of the Maple Grange Football Field, (iii) paragraph (e) of said Section 3, the sum of \$50,000 from the capital fund balance of the Township and (iv) paragraph (f) of said Section 3, the sum of \$291,604 from the open space fund of the Township.

Section 2. For the financing of said improvements or purposes and to meet the part of said \$4,015,000 appropriations not provided for by application hereunder of said down payments, grant and monies available in various funds of the Township, negotiable bonds of the Township are hereby authorized to be issued in the principal amount of \$3,130,000 pursuant to the Local Bond Law of New Jersey. In anticipation of the issuance of said bonds and to temporarily finance said improvements or purposes, negotiable notes of the Township in a principal amount not exceeding \$3,130,000 are hereby authorized to be issued pursuant to and within the limitations prescribed by said Local Bond Law.

Section 3. The improvements hereby authorized and the several purposes for the financing of which said obligations are to be issued, the appropriation made for and estimated cost of each such purpose,

and the estimated maximum amount of bonds or notes to be issued for each such purpose, are respectively as follows:

- (a) Acquisition by purchase of new and additional equipment including, without limitation, one (1) skid steer, one (1) fleet lift, one (1) jib crane and one (1) all terrain vehicle for use by the Department of Public Works of the Township, and self-contained breathing apparatus, turnout gear, one (1) all terrain vehicle and various equipment for use by the Fire Departments of the Township, together with all site work, attachments, accessories and equipment necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Township Clerk and hereby approved
- (b) Improvement of various streets in and by the Township by the construction or reconstruction therein of a roadway pavements at least equal in useful life or durability to a roadway pavement of Class B construction (as such term is used or referred to in Section 40A:2-22 of said Local Bond Law), together with all structures, appurtenances, milling, curb and sidewalk reconstruction, drainage retaining improvements, guide rails. equipment, work and materials necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Township Clerk and hereby approved, the \$950,000 appropriated therefor being inclusive of the sum of \$181,200 received or expected to be received by the Township from the New Jersey Department of Transportation as a grantin-aid of financing said improvement
- (c) Acquisition by purchase of new and additional vehicular equipment including, without limitation, one (1) dump truck and truck radios and other equipment for use by the Department of Public Works of the Township and one (1) ambulance for use by the Ambulance Squad of the Township, together with all equipment, attachments and accessories necessary therefor or incidental thereto, all as shown on and in accordance with the

specifications therefor on file or to be filed in the office of the Township Clerk and hereby approved

- (d) Improvement of municipally-owned properties and facilities in and by the Township including, without limitation, Maple Grange Park by the upgrade of the football field, Veteran's Park by the construction of an ADA compliant pathway, the snack bar by the installation of new lighting, and the acquisition and installation of tanks for the fueling station, together with all equipment, structures, site work, work and materials necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Township Clerk and hereby approved, the \$970,000 appropriation hereby made therefor being inclusive of the amount of \$62,000 from funds on hand of the Township for the improvement of the Maple Grange Park football field
- (e) Acquisition, by purchase, of new and additional fire fighting equipment for the preservation of life and property in the Township, consisting of one (1) tanker truck for use by the Fire Department of the Township, including all equipment, appurtenances, accessories and attachments necessary therefor or incidental thereto, all as shown on and in accordance with the specifications therefor on file or to be filed in the office of the Township Clerk and hereby approved, the \$440,000 appropriation hereby made therefor being inclusive of the amount of \$50,000 from capital fund balance of the Township
- (f) Improvement of municipally-owned properties and facilities in and by the Township by the construction of a new bike pump track, bike path and walking path, together with all paving, roadway and parking lot improvements, landscaping, engineering, designs, equipment, structures, site work, work and materials necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Township Clerk and hereby approved, the \$900,000 appropriation hereby made therefor being inclusive of the amount of \$291,604 from the open space fund of the Township

Except as otherwise stated in paragraphs (b), (d), (e) and (f) above with respect to the said grant-in-aid and the said funds available in various fund of the Township for financing the improvements or purposes described in said paragraphs (b), (d), (e) and (f), the excess of the appropriation made for each of the improvements or purposes aforesaid over the estimated maximum amount of bonds or notes to be issued therefor, as above stated, is the amount of the said down payment for said purpose.

Section 4. The following additional matters are hereby determined, declared, recited and stated:

- (a) The said purposes described in Section 3 of this bond ordinance are not current expenses and each is a property or improvement which the Township may lawfully acquire or make as a general improvement, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.
- (b) The average period of usefulness of said purposes within the limitations of said Local Bond Law and taking into consideration the respective amounts of the said obligations authorized for the several purposes, according to the reasonable life thereof computed from the date of the said bonds authorized by this bond ordinance, is 11.64 years.
- The supplemental debt statement required by said Local Bond Law has been duly made and filed (c) in the office of the Township Clerk and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey, and such statement shows that the gross debt of the Township as defined in said Local Bond Law is increased by the authorization of the bonds and notes provided for in this bond ordinance by \$3,130,000, and the said obligations authorized by this bond ordinance will be within all debt limitations prescribed by said Local Bond Law.
- Amounts not exceeding \$500,000 in the aggregate for interest on said obligations, costs of (d) issuing said obligations, engineering costs and other items of expense listed in and permitted under Section 40A:2-20 of said Local Bond Law may be included as part of the costs of said improvements and are included in the foregoing estimate thereof.
- Section 5. The funds from time to time received by the Township on account of the \$181,200 grant referred to in Section 1 of this bond ordinance shall be used for financing the improvement or purpose described in Section 3(b) of this bond ordinance by application thereof either to direct payment of the cost of said improvement or purpose, or to payment or reduction of the authorization of the obligations of the Township authorized by this bond ordinance. Any such funds so received may, and all such funds so received which are not required for direct payment of such cost shall, be held and applied by the Township as funds applicable only to the payment of obligations of the Township authorized by this bond ordinance.

Section 6. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the Chief Financial Officer, provided that no note shall mature later than one year from its date. The notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with the notes issued pursuant to this bond ordinance, and the Chief Financial Officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of Section 40A:2-8 of said Local Bond Law. The Chief Financial Officer is hereby authorized to sell part or all of the notes at no less than par from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the dates of delivery thereof. The Chief Financial Officer is directed to report in writing to the governing body of the Township at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this bond ordinance is made. Such report must include the principal amount, interest rate and maturities of the notes sold, the price obtained and the name of the purchaser.

Section 7. The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and interest on the said obligations authorized by this bond ordinance. Said obligations shall be direct, unlimited obligations of the Township, and the Township shall be obligated to levy ad valorem taxes upon all the taxable property within the Township for the payment of said obligations and interest thereon without limitation of rate or amount.

Section 8. The capital budget or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Township Clerk and are available for public inspection.

Section 9. This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by said Local Bond Law.

PUBLIC COMMENTS (Limited to 3 Minutes On Any Topic)

Council President Shortway asked for a motion to open the meeting for Public Comments.

MOTION: Kelly Weller SECOND: Toni Cilli

All members were in favor.

Walter Marsico – Vernon Township, asked Administrator Voelker how long he has lived in Vernon and if he is going to supervise the Vernon employees especially Mr. Westenberger. He said no one has returned emails. Ms. Marsico feels that Mr. Westenberger is breaking the UCC Code. He told Administrator Voelker that he doesn't live in Vernon and has no vested interest in Vernon. He also feels that what Mr. Westenberger is being allowed to do is wrong and illegal. Mr. Marsico said he is not going away and he is not going to allow what is being done and he said he promises that you will not get away with it. He asked if anyone found out who took the pictures at night in a personal vehicle of the interior of his residence.

Peg Distasi – Vernon Township, she feels that if she adds up all the figures you are taking \$600,000 out of the Open Space fund, \$290,000 that was authorized years ago and another \$300,000 to purchase the Baldwin Property. That leaves about \$320,000 in the Open Space fund. That is taxpayer money that is going towards the trails. Ms. Distasi said you are paying for roads to be paved and a new road to be put in for the pump track. When you add this up it comes to about \$1,200,000 for a trail that we were told no taxpayer money would be used by the Mayor at the time Harry Shortway.

Paul Webber – Vernon Township, sent a chat saying the farmer's market was a success and it was nice to see the Mayor and his wonderful wife.

Seeing no other members of the public wishing to speak, Council President Shortway asked for a motion to close the meeting for Public Comments.

MAYOR COMMENTS

Because of the stand that the Mayor and Council took in October of last year in support of our volunteers, we have seen a resurgence in individuals' desire and willingness to serve on our volunteer boards, committees, and commissions.

And on tonight, it's my pleasure and honor to appoint a new volunteer who has requested to serve on one of our most impactful and appreciated committees, the Beautification Committee.

I appoint Ms. Kristen Hess, a Certified Mortgage Advisor and Real Estate Agent.

Ms. Hess will join a team that has received an overwhelming amount of appreciation and praise from Vernon residents, Vernon businesses, as well as visitors to our town.

Welcome Ms. Hess!

All of my education, training, and experiences tell me that the best predictor of an individual's future performance, is their past behavior.

And in spite of the fact that this statement has been repeatedly proven to be true throughout the decades, the teachings of my faith, plus some rare experiences, have demonstrated to me that when the desire is strong and the will is determined, people can change.

It was this thought process that gave me hope that Mr. Joe Wallace and his Facebook collaborators would have a change of heart and mind; that they would do the civically responsible thing and follow the town's example - - as demonstrated by our quick, thorough and complete cleanup of the decades-old debris field on a piece of town property, to which Mr. Wallace and his Facebook collaborators so eagerly and joyfully directed the DEP - -

It was my hope that Mr. Wallace and his Facebook collaborators would follow the town's example and focus their time and efforts on cleaning up the illegal waste mountain that Mr. Wallace has created in the Silver Spruce Drive area of our town.

However, that has not been the case.

And so on tonight I provide you 4 brief points, as a way of updating you as to the town's efforts to get this illegal waste mountain cleaned up.

POINT 1: The State of New Jersey, specifically the Department of Environmental Protection, has filed a suit against Mr. Wallace compelling him to not only cease the illegal dumping on his property, but also requiring him to clean-up the illegal waste mountain that he created.

The Department of Environmental Protection is managing this case through the Office of the Attorney General. And because the Attorney General's Office is the legal authority that is currently in control of the Wallace case, this dictates the extent and speed at which Vernon Township can make forward movement on getting this illegal waste mountain cleaned up.

POINT 2: Your governing body team, through the Mayor's Office, is in frequent contact with the specific Deputy Attorney General who is in charge of the Wallace case.

Mr. Wallace's case, like so many other court cases, has been repeatedly postponed because of COVID-19 restrictions. The Deputy Attorney General handling this case recently advised that his office has been, and continues to be, actively involved in searching for Mr. Wallace's funds that can be used for this illegal waste mountain cleanup.

The Deputy Attorney General also recently informed us that as part of their efforts to locate the large sum of funds that it is assumed Mr. Wallace made from his illegal dumping operation, the Attorney General's Office was scheduled to question a relative of Mr. Wallace in a legal setting on April 20; however, her legal counsel requested and received a last-minute delay.

In response, the Attorney General's Office has filed a motion with the court to compel this relative to appear for this legal questioning without additional delay.

POINT 3: Also, as part of the process of obtaining funds that can be used for the cleanup of this illegal waste mountain, the Honorable James Rothschild, the retired Superior Court Judge who has been appointed receiver of Mr. Wallace's estate, has sold some of Mr. Wallace's assets.

The town has not yet been advised as to the specific amount of funds that have been raised through Judge Rothschild's efforts. And ...

POINT 4: As our way of doing everything that we can to prevent our town's local taxpayers from having to foot any portion of the bill to clean-up Mr. Wallace's waste mountain, and to heal the civic black eye that Mr. Wallace has given our town, the Mayor and Council have been in active pursuit of any state and/or federal funds that we could possibly obtain for this cleanup purpose.

The Mayor and Council will continue to keep close tabs on this Wallace matter, and we will do everything that we can to keep you appropriately informed.

For those of you who were able to visit our Farmers' Market's 2021 Grand Opening this past Saturday, you already know that the Vernon Famers' Market is not only back, but it's back bigger than ever!

The Vernon Famers' Market is but one testament to the unique value that volunteers bring to our town.

It's my understanding that the Vernon's Farmers' Market was started three years ago by municipal volunteers, Ms. Toni Cilli, before she became a Council Member, and Ms. Cheryl Shortway. I am told that they also had the strong support of another group of volunteers - - the volunteers on the Greenway Action Advisory Committee.

Our Farmers' Markets have now developed into biweekly events that are highly anticipated by many in our town and in the surrounding communities.

Last year's Farmers' Markets saw visits by a steady stream of both, long time and new Vernon residents, plus frequent visits by a meaningful number of out-of-town visitors who often stopped by our Farmers' Markets before and/or after walking a portion of the Appalachian Trail.

The municipal coordinator of our farmers' markets, our town's Director of Recreation and Community Development, Ms. Michelle Downtain, tells me that our farmers' markets could not be possible, nor could they be successful, without the host of dedicated municipal volunteers who donate their time and effort for the town that they love.

As I walked around Saturday's Farmer's Market and greeted the vendors and the visitors in attendance, all while enjoying a beautiful warm spring day in Vernon Township, I couldn't help but think about the fact that there is something that's mentally and emotionally healing for us humans in the repeated refrains of nature; and that is the assurance that the warmth of spring and summer will always come, even after a hard, cold winter!

Our next Famers' Market will be hosted on Saturday, June 12, from 9am-1pm; if your schedule permits, please join us.

COUNCIL COMMENTS

Vice President Auberger commented saying that he and the Mayor reached out to the VFW to see if there was a way to help get the Memorial Day parade to happen. Unfortunately, it was too late to get the permits from the State. They will be hosting a Memorial Day ceremony at Veteran's Memorial Park on Monday at 11:00 am and Vice President Auberger hopes that a lot of people come to support this. Vice President Auberger said if the Mayor would like they could possibly have a Fourth of July parade being that the Memorial Parade did not happen.

Council Member Weller said she is sorry she missed the farmer's marker but she heard it was a huge success and she is hoping to be there in the coming weeks.

Council Member Pitsker commented saying we may need more room for the farmer's market. It was great to see the first one like that and hopefully we will see some kind of normal.

Council Member Pitsker said that CFO Bright did a great job with her presentation and asked if it could be published on the website and added to the minutes.

Council Member Cilli said she is sorry she missed the farmer's market as well but someone bought her honey from the farmer's market. She told the Mayor that she loves that he goes and supports it every time. It is bigger and better than ever.

Council Member Cilli wanted to thank Craig Williams and the GGAC committee for arranging the trail cleaning and there were so many volunteers that hopefully there will be a few more trails to clean.

COUNCIL PRESIDENT COMMENTS

I have been conducting research into the East 300 Upgrade Project compressor issue for several weeks.

The East 300 Upgrade Project will increase natural gas capacity through the existing Tennessee Gas Pipeline system to meet the market needs of Consolidated Edison Company of New York.

Published articles break down into pro fossil fuel or green economy/anti-fracking. Some government officials are accused by progressives/liberals of being influenced by monolithic energy companies. Fossil fuel advocates counter their opponents lack credible research that backs their allegations. https://www.utne.com/environment/effects-of-air-pollution-zm0z15fzsau

The East 300 Upgrade Project does cause concerns. Allegations by opponents rely on questionable information. For example: The pipeline crosses Vernon. Opponents claim the pipeline is 65 years old. The initial line may be that old. However, a 30" pipe was installed approximately ten years ago.

Independent studies are difficult to find.

Opponents of the project include Food & Water Watch and the Southwest Pennsylvania Environmental (SPE) Health Project. Their initiatives are funded in part by the Park Foundation.

The Safety Assessment of Large Shale Gas Compressor Stations in Residential Neighborhoods in New York State was funded by The **Park Foundation**. This foundation has been a major supporter of the anti-<u>fracking</u> movement. The foundation has donated hundreds of thousands of dollars to Food & Water Watch and SPE since 2008.

SPE conducted a pilot project in Minisink, NY around a newly built shale gas compressor station in 2014.

Results include:

One of the most important lessons learned by participants is that local weather patterns play a large role in exposures to outdoor pollutants, for homes, neighborhoods, schools and other community spaces.

Acute health symptoms may result from these exposures. Based on community results and emerging published research, SPE determined that health impacts from shale gas compressor stations were not only plausible, but also likely.

However, The East 300 Upgrade Project has approvals from the New Jersey Department of Environmental Protection and the Highlands Council.

A Federal Energy Regulatory Commission environmental review also found that the project "would not constitute a major federal action significantly affecting the quality of the human environment."

Highlands Council Executive Director wrote, "The efforts to avoid, minimize and mitigate for resource impacts are sufficient to find that the project is consistent with the goals of the Highlands Act.

TGP will conduct a presentation next month to address the Project.

I submitted the following questions to them in anticipation of the presentation.

Will there be periodic reviews of PM and VOC exposures, especially during blowdown events and times of poor air quality?

Will venting and blowdowns during times of poor air dilution be prohibited?

Will there be notifications in advance of large releases including blowdowns within a minimum distance of 1.25 miles of the compressor and notification of accidental releases?

Will compressor station emission levels be available to the public for review?

Will periodic health studies to track community health effects of residents within 1.25 miles of the compressor be conducted?

If so, what method will be used?

The Rand Corporation developed the SF-36 survey, is this survey under consideration?

Will there be particulate matter monitoring stations using Speck Sensors?

At this time, I will not support a Resolution in opposition to the Project until TGP has an opportunity to answer public questions and explain their position.
