### **MAYOR COMMENTS**

Thank you, council president. I just have a couple of items to discuss. Again, congratulations to Dane Walker of troop 912. This is a huge step. Being an Eagle Scout will prepare you for the future. This is an achievement that must be added to your resume, because this tells you something about who this young man is.

Also, to all who you may or may not know Vernon only has 33 officers who cover 70 sq miles and close to 25k residents, this is significantly less than most townships. The resolution before you is for the new police hire Robert Baumann. This was initiated because SGT Mutz will be retiring in August. Last week we had a full panel interview headed up by Lt Dan Young Along with Capt. Jason Haw, Dt Curry myself and Business Administrator Tina Krause which was overseen by Chief Dan Young. We all had an opportunity to ask the applicant a series of questions. Mr. Baumann has obviously has gone through an extensive back ground check. To even get to this stage, plus he is currently a part time dispatcher for Bergen County dispatch center and Vernon. Mr. Baumann is also born and raised in Vernon.

To all of the contractors or homeowners in Vernon our building dept hours has changed from 8:30 to 4:00 to 8:00 to 4:00. I know this may not seem much to some but it does mean a lot to other. I have learned that we did have a few people come to our building dept at this time, so glad to see it is working.

There are a couple of other things happening in town:

June 12th there will be a helicopter flying low checking all the JCP&L transmission lines as a routine patrol, so don't be alarmed.

I know there has been many complaints about the vegetation on the medium on 515. I just want to be clear that we have called this into the county to have taken care of, but some like to blame the Mayor for the weeds, so If that's all the complaints some may have I will take it.

Also, I want to mention 3 people who originally applied to the beautification committee. One person applied to the EDAC committee and she mentioned in her application or the beautification committee. I have selected her to be on the EDAC, because she was on that committee last year and wanted no part of it this year. I have asked her to please reconsider because we will have a whole new board and chairman. We have a great group of local businessmen and professionals who no server and these meetings are run professionally and respectfully by Mr. Peter Knipe, So that leaves me with 2 individuals, and I did not want to discuss this on this forum but the other applicant is my daughter Marissa and she is going to make me a grandfather, so as many first time mothers know it can be very exhausting and stressful being pregnant, plus she currently works as an awesome Mortgage broker, so that leaves only one applicant that I will not call because it's too much for one person to manage, but like everything else we welcome our volunteers.

Also, the old BOE property was addressed, this is another issue we addressed internally. We must work with our property owners and not fine them for over grown weeds, I'm not doing it! This is not business friendly approach! I have also requested to have new trees planted in the median on rt 515, and in between each of those trees will be stone planters made up of over 2 inches of concrete and wrapped in beautiful stone work (more to follow), This is just one step closer to enhancing the look of our town center which we can all agree looks horrible. We are also looking for donations for a town clock which would be surrounded by stone planters. Ya know the old saying when life hands you lemons you turn them into lemonade, and that's exactly how I view that median on Route 515. I will hope to have some more detailed plans for review soon.

Also, on Route 515 the catch basin in front of the back that was supposed to have been taken care of on 6/17 was moved up to this afternoon, so thank you to our county friends.

Also, thank you to our clerk's office and DPW for setting up the poll machines, their day began at 4:30 in the morning and went into the evening.

June 23rd is Vernon's first car show so please come to the Vernon fire house. There will be a lot to see plus it's for support of our local fire and EMS, so please come and support them.

Also, something else for next year. I am currently on bringing the Carnival back. I have had a discussion with the Warwick fire dept who said it's a huge revenue maker for them, so we will do the same for Vernon.

Council Member Higgins commented that there are a number of dilapidated houses in town that are vacant with old cars on the property. Council Member Higgins asked what the rules are for this.

Council Member DeBenedetto questioned if the town was going to have a carnival like they did in the past at the church.

Council Member Sparta thanked everyone who had a part in Vernon Day on Saturday. It was a nice day. Council Member Sparta commented saying this something that I have toiled with for the last few weeks. I am a staunch supporter of the delineation between the BOE and the council. We are two separate elected bodies with very distinct and separate responsibilities. Back in 2011or 2012 Governor Christie allowed BOE to move their elections to November as long as their budget didn't go over a cap. Myself and John McGowan voted to keep the elections in April so the budget could be still voted on by the community. Needless to say, we were on the wrong side of that vote and the vote on the budget was removed. A few meetings ago a member of the community mentioned that there is a process by which the council can have the school budget moved back to April and be voted on by the community. I have some strong conflicting feelings on whether or not we as a council should consider this. I feel if we do decide to move forward with this it really blurs that line of distinction between the BOE and the council. Also, there are some community members that don't know there is a difference between the two bodies and this would only add to that confusion and may play a part in a delay in having a problem rectified by them going to the wrong elected body if they have an issue. On the other hand, the town is the fiduciary for the taxes received through property taxes. I have some significant concerns with where the school budget is at and where it is heading. Iam not going to discuss those concerns here because it is not the time or the place. Mr. Council President, may I ask that we have a discussion item on the agenda for our next meeting where our attorney can present the process that is available to the council to place the school budget on the ballot for a community vote next April? And after that is presented to us, we as a council have a discussion as to whether this is something we want to consider doing or leave it as is.

### **COUNCIL PRESIDENT COMMENTS**

Council President Rizzuto commented that we are in the graduating season and school will be closing, he asked that everyone be careful on the roads with children playing outside. Council President Rizzuto feels that it is a good time to review the sign ordinance to extend some courtesy to businesses. He also feels

that our compliance officer needs to review setback for projects that are close to the road to check for safety issues.

## **ADJOURNMENT**

At 8:12 pm Council Member Higgins made a motion to adjourn the meeting. Seconded by Council Member DeBenedetto.
