OLD BUSINESS

1. BOE Building

Commission members noted that the BOE building on Route 515 has been demolished. Former chairperson Harris Salomon had written to Land Use Administrator Kim Decker for a cease and desist, asking that demolition not take place before the HPC has the opportunity to review the demolition permit. However, the demolition had moved forward.

2. Legends Resort

Mayor Anthony Rossi arrived at the meeting at about 8:15. Harris Salomon questioned the mayor about the current status of ownership of the resort. Mayor Rossi said that Charles Everhardt was still pursuing financing and the resort had not fully changed hands yet. The mayor said he questions

whether the deal might fall through. Harris Salomon stated he would like to pursue nomination of the resort for township landmark status on the Master Plan. Commissioners Jodi White-Bearstler and Lisaann Van Blarcom Permunian reminded him that the commission had decided at the December 5, 2024, meeting to postpone nomination of the resort at this time.

3. Hinchman-Rickey Farm

Jamie Rickey presented email from Will Brown, the owner of the farm. In the email, Mr. Brown said he was not opposed to giving the property township landmark status on the Master Plan. The property and structures on the farm are already listed on the New Jersey Register of Historic Places. Jamie Rickey will prepare the township nomination.

4. Vernon Crossing Road Train Station

Harris Salomon will prepare the nomination for the train station, known today as The Tracks Deli.

5. HPC Secretary Search

Temporary volunteer secretary Jessi Paladini announced that she had spoken with Debbie Coulson. who had previously been the secretary for the HPC and also for the Environmental Commission. Ms. Coulson agreed to serve as secretary for the HPC. At this time, the commission asked the mayor if there would be funding for the HPC to pay the secretary. The mayor committed to allocating \$2,000 for the HPC for 2025. After a brief discussion, commission members agreed to pay Ms. Coulson \$20 an hour to attend meetings, write the monthly minutes, and anything else the commission should seek of the secretary.

1. Public Hearing – Perry Farm

The commission held a public hearing for the nomination of the Perry Farm. A certified letter was sent to owner Dale Kelly notifying him of the public hearing, but Mr. Kelly was not present at the hearing. While Mr. Kelly said he did not object to the listing of the property on the Master Plan, he said he was demolishing the house on the property because a tree fell on it and the insurance company will no longer insure the house. On a motion by Jodi White-Bearstler, the meeting was open to the public for comment. Lisaann VanBlarcom Permunian seconded the motion. Seeing no members of the public present, the meeting was closed to the public and the commission proceeded with the nomination for recommendation to the Land Use Board and the Town Council to give the property landmark designation and list it on the township Master Plan. Jodi White-Bearstler moved to proceed with the nomination. Lisaann VanBlarcom Permunian seconded the motion.
